

ORDINANCE NO. 149243

An Ordinance creating one position of Business Assistance Representative in the Bureau of Economic Development; abolishing one position of Typist Clerk and two part-time positions of Staff Assistant in the Bureau of Economic Development; and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

1. The Bureau of Economic Development requires one position of Business Assistance Representative for the Industrial Districts project.
2. One Typist Clerk position, created by the 1979-80 budget in the Office of Planning and Development and transferred to the Bureau of Economic Development By Ordinance 147977, is no longer required.
3. Two part-time Staff Assistant positions, created by the 1979-80 budget in the Office of Planning and Development and transferred to the Bureau of Economic Development by Ordinance 147977, are no longer required.
4. Savings created by abolishing these three positions will be sufficient to fund the position of Business Assistance Representative being created.
5. The Bureau of Personnel Services has reviewed and concurs with this action.

NOW, THEREFORE, the Council directs:

- a. One position of Business Assistance Representative is hereby created in the Bureau of Economic Development as follows:

- b. The following positions in the Bureau of Economic Development are hereby abolished as follows:
