# ORDINANCE NO. 149213

An Ordinance creating one position of Business Assistance Representative in the Bureau of Economic Development; abolishing one position of Typist Clerk and two part-time positions of Staff Assistant in the Bureau of Economic Development; and declaring an emergency.

The City of Portland ordains:

## Section 1. The Council finds:

- 1. The Bureau of Economic Development requires one position of Business Assistance Representative for the Industrial Districts project.
- 2. One Typist Clerk position, created by the 1979-80 budget in the Office of Planning and Development and transferred to the Bureau of Economic Development By Ordinance 147977, is no longer required.
- 3. Two part-time Staff Assistant positions, created by the 1979-80 budget in the Office of Planning and Development and transferred to the Bureau of Economic Development by Ordinance 147977, are no longer required.
- 4. Savings created by abolishing these three positions will be sufficient to fund the position of Business Assistance Representative being created.
- 5. The Bureau of Personnel Services has reviewed and concurs with this action.

## NOW, THEREFORE, the Council directs:

a. One position of Business Assistance Representative is hereby created in the Bureau of Economic Development as follows:
