## ORDINANCE No. 149216

An Ordinance authorizing a contract with Hessel Tractor Equipment Corp. pursuant to Bid No. 83, opened February 19, 1980, for one Tractor/Backhoe/Loader for the sum of \$29,227 for the Bureau of Fleet Management, authorizing the drawing and delivery of warrants, waiving performance bond and declaring an emergency.

The City of Portland ordains:

#### Section 1. The Council finds:

- 1. The Purchasing Agent has advertised and received proposals for furnishing one Tractor/Backhoe/Loader for the Bureau of Fleet Management for assignment to the Water Bureau, said bids being opened February 19, 1980.
- 2. Hessel Tractor and Equipment Corp. submitted a bid in the amount of \$29,227 and was the lowest bidder.
- 3. The Manager of the Bureau of Fleet Management recommends and the Commissioner of Public Utilities concurs, that a contract should be awarded to Hessel Tractor and Equipment Corp.

## NOW, THEREFORE, the Council directs:

- a. The Mayor and the Commissioner of Public Utilities hereby are authorized to enter into a contract with Hessel Tractor and Equipment Corp., 1425 N.E. Columbia Blvd., Portland, Oregon, for furnishing one Tractor/Backhoe/Loader for the total sum of \$29,227, said contract shall be approved as to form by the City Attorney and a performance bond requirement from the contractor hereby is waived.
- b. The Mayor and Auditor hereby are authorized to draw and deliver to Hessel Tractor and Equipment Corp., 1425 N.E. Columbia Blvd., Portland, Oregon, a warrant or warrants chargeable to the 1979-80 Budget, Equipment (56200037/643), when demand is presented, approved by the proper authorities.
- Section 2. The Council declares that an emergency exists because delay in proceeding with this purchase may result in additional expenses to the City and will unnecessarily deprive the Water Bureau of the benefits of completion of the contract at an early date; therefore, this ordinance shall be in force and effect from and after its passage by the Council.
