An Ordinance transferring appropriations in the amount of \$6,000 within the Budget of the Bureau of Human Resources Training and Employment Division (TED), and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

- Out-of-Town Travel is a controlled line item which should not be over-1. expended.
- 2. Due to necessary trips to Department of Labor meetings in Washington and training sessions in Seattle, the TED appropriation for Out-of-Town Travel is over-expended.
- A transfer of \$6,000 within Materials and Services to line item 430, Out-3. of-Town Travel, within the TED budget will provide sufficient appropriation to correct the over-expenditure.
