

ORDINANCE NO.

149260

An Ordinance creating a new section within Title 20 establishing playing rates for the St. Johns Racquet Center, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds that the Bureau of Parks operates the St. Johns Racquet Center for the benefit of the general public; that playing rates for the use of these courts should be established; and that the Superintendent of Parks and Commissioner in charge of the Bureau of Parks recommend a new section within Title 20 to establish such rates;

NOW, THEREFORE, a new section hereby is created within Title 20 establishing playing rates for the St. Johns Racquet Center as follows:

20.48.010 (a) The following rates shall be charged for the use of tennis courts at St. Johns Racquet Center:

for each 60 minute period:

| Adults: | <u>Fall, Winter, Spring</u> | <u>Summer</u> |

| Singles | \$3.00/player | \$2.00/player |
| Doubles | \$2.00/player | \$1.00/player |
| Season | \$104.00/court | \$52.00/court |

(b) The following rates shall be charged for special group tennis events as established by the Superintendent of Parks:

Adults \$3.00/player
Juniors \$2.00/player

(c) The following rates shall be charged for group tennis lessons consisting of eight one-hour lessons:

Adults \$15.00
Juniors \$ 7.50

(d) The following rates shall be charged for the use of racquetball/handball courts at St. Johns Racquet Center:

For each 60 minute period:

Adults \$2.00/player
Juniors \$1.00/player
Season \$52.00/court

- (e) The following rates shall be charged for group racquetball lessons consisting of six one-hour lessons:

Adults \$15.00
 Juniors \$ 7.50

- (f) There will be four seasons for tennis and racquetball/handball:
 Summer, July 1 to September 30; Fall, October 1 to December 31;
 Winter, January 1 to March 31; Spring, April 1 to June 30.

- (g) From October 1 to November 15 and March 16 to June 30, the following rates will be charged for the Portland Tennis Center Association, Portland Public Schools and Oregon School Activities Association, subject to availability of time as determined by the Superintendent of Parks or his designee:

- (1) Appropriate singles flat court fee will be charged.
- (2) A minimum of 50% per day of court hours reserved will be charged if courts are cancelled with less than 7 days notice.
- (h) Pros will pay 15% of lesson fees charged in addition to the appropriate court charge.
- (i) For a period of one year after the opening of the Racquet Center for public use, the Commissioner in charge of the Bureau of Parks and Recreation shall be authorized to establish special promotional rates less than herein established and to authorize periods of free play.

Section 2. Inasmuch as this ordinance is necessary for the immediate preservation of the public health, peace and safety of the City of Portland in this: In order that the rates outlined in Section 1 hereof may be established without undue delay, therefore an emergency hereby is declared to exist and this ordinance shall be in force and effect from and after its passage by the Council.
