

ORDINANCE No. 149272

An Ordinance abolishing one position of Building Permit Supervisor and creating in lieu thereof one position of Permit Center Supervisor in the Bureau of Buildings, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

1. It is recommended that one position of Building Permit Supervisor (3222) be abolished and that one position of Permit Center Supervisor (3222) be created in lieu thereof.
2. The change described herein has no significant budgetary effect on the bureau involved.
3. The change has been approved by the Bureau of Personnel Services.


NOW, THEREFORE, the Council directs:

- a. One position of Building Permit Supervisor in the Bureau of Buildings is hereby abolished.
- b. One position of Permit Center Supervisor is hereby created in lieu thereof with salary rate in accordance with the current Compensation Plan.


