

ORDINANCE No. 149273

An Ordinance transferring \$8,000 in appropriation within the Housing and Community Development Fund for Local Improvement District assessment and advertising; and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

1. That the Office of the Auditor incurs expenses for Auditor's fees and advertising for Local Improvement Districts (LID) for Housing and Community Development Street improvement projects.
2. That it is appropriate for the Housing and Community Development Fund to cover these expenses.
3. That \$8,000 needs to be transferred within the Housing and Community Development Fund to cover estimated costs for the remainder of FY 79-80.

NOW, THEREFORE, the Council directs:

- a. That the 1979-80 budget is hereby amended as follows:

Housing and Community Development Fund

Requirements

General Operating Contingency 53000011/710	(8,000)
Housing and Community Development	8,000
Materials & Services 53200010/2000/590	

Section 2. The Council declares that an emergency exists because the appropriation is needed immediately in the account to which it is to be transferred, so that there may be no delay in processing LIDs. Therefore, this ordinance shall be in force and effect from and after its passage by Council.
