ORDINANCE No. 149273

An Ordinance transferring \$8,000 in appropriation within the Housing and Community Development Fund for Local Improvement District assessment and advertising; and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

- That the Office of the Auditor incurs expenses for Auditor's fees and advertising for Local Improvement Districts (LID) for Housing and Community Development Street improvement projects.
- 2. That it is appropriate for the Housing and Community Development Fund to cover these expenses.
