## ORDINANCE No. 149280

An Ordinance authorizing the Purchasing Agent to advertise and receive proposals for a contract furnishing the labor, equipment and materials for painting and roof repair of Marquam Hill No. 1 Tank, and exterior painting of Kelly Butte Tank, authorizing a contract with the most favorable bidder, the drawing and delivery of warrants, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

1. To continue and implement the Bureau of Water Works' program of reservoir and tank maintenance, it is necessary to paint the exterior of Kelly Butte Tanks, and also perform roof repair and painting of Marquam Hill No. 1 Tank.

NOW, THEREFORE, the Council directs:

- a. The Purchasing Agent shall advertise for bids using specifications filed in his office on MAR 7 1992 and in the event that no satisfactory bid is received, shall readvertise on the same basic specifications until a satisfactory bid is received.
- b. A contract is authorized with the most favorable bidder as designated by Council.

c. The Mayor and the Auditor hereby are authorized to draw and deliver warrants charged to the 1979-80 Budget, Water Fund, BUC No. 18600374, Budget Object Code 630, Project No. 3736, when demand is presented and approved by the proper authorities.

Section 2. The Council declares that an emergency exists because a delay in proceeding with the painting and repair may result in additional expense and will unnecessarily delay the proper maintenance of Water Bureau tanks; therefore, this Ordinance shall be in force and effect from and after its passage by the Council.
