## ORDINANCE No. 149290

An Ordinance authorizing the acceptance of a sculpture by Evelyn Franz, authorizing the placement of the sculpture in Laurelhurst Park, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

- 1. That Evelyn Franz has been employed as part of the Metropolitan Arts Commission's CETA Visual Art in Public Places Program; and her project as part of this program is to create a sculpture for Laurelhurst Park.
- 2. That the sculpture has been approved by members of the Metropolitan Arts Commission, the Park Bureau, the Laurel-hurst Neighborhood Association, Risk Management, Portland Police Bureau Crime Prevention and Security, and the Commissioner in charge.
- That Section 20.12.310 of the City Code requires that Council approve the placement of any sculpture in any park or public grounds.

NOW, THEREFORE, the Council directs:

a. That the sculpture by Evelyn Franz be accepted and the placement of the sculpture in Laurelhurst Park be approved, the location to be approved by the Superintendent of Parks.

Section 2. The Council declares that an emergency exists because delay in the acceptance and placement of the sculpture would result in undue delay in assuming control of the art work; therefore this Ordinance shall be in force and effect from and after its passage by the Council.
