ORDINANCE NO. 149202

An Ordinance amending City Contract No. 17794 with William L. Sloan to authorize use of a motorized vehicle in operation of the concession at O'Bryant Square subject to certain conditions, and declaring an emergency.

Section 1. The Council finds:

- (1) That the city has heretofore contracted with William L. Sloan for concession privileges at O'Bryant Square;
- (2) That such agreement being City Contract No. 17794 prohibits use of motorized vehicles in the operation of the concessions;
- (3) That William L. Sloan, Concessionaire at O'Bryant Square has requested the use of a motorized vehicle in connection with the concession operation;
- (4) That the use of a small motorized vehicle in connection with the concession operation would be beneficial to use of the park from a visual and service standpoint and has been approved, subject to certain conditions by the Commissioner in Charge and the Superintendent of Parks;
- (5) That such agreement should be provided to authorize use of a small motorized vehicle by William L. Sloan in O'Bryant Park, subject to certain conditions;

NOW, THEREFORE, the Council directs:

- (a) Amendment of Contract No. 17794 between the city and William L. Sloan for the concession privileges at O'Bryant Square is hereby authorized to allow use of a motorized vehicle in connection with the concession service provided by Mr. Sloan, subject to the following conditions:
 - (1) That the design of the motorized vehicle to be used shall be subject to approval by the Commissioner in charge and the Superintendent of the Bureau of Parks;
 - (2) That the motorized vehicle shall be required to provide adequate protection to prevent the leakage of oil or other materials on park property;
 - (3) That the motor of the vehicle shall be left running only so long as is necessary to enter and leave the park;

Section 2. This ordinance shall be an effective amendment of said Contract No. 17794 between the city and William L. Sloan, upon acceptance of the conditions of this ordinance in writing filed with the City Auditor.

ORDINANCE No.

Section 3: The Council declares:

In order that authorization for use of a motorized vehicle in O'Bryant Square may be granted without undue delay, therefore, an emergency exists and this ordinance shall be in force and effect from and after its passage by the Council.
