ORDINANCE NO. 149295

An Ordinance designating the incumbents in certain positions as signatories on Payment Vouchers on Letters of Credit for various Federal Granting Agencies, authorizing certification, terminating appointments made by Ordinance No. 145719, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

- From time to time various Federal Granting Agencies require validation and certification of the municipal officers and employees authorized by the City to sign Payment Vouchers on Letters of Credit. It is desirable for the City to designate signatories by position because individuals change from time to time. It is now necessary to redesignate the positions authorized as signatories due to position changes.
- 2. The City Auditor would attest to the signature of the specific individual in a designated position and continuity would be maintained by designating more than three signatories to validate Payment Vouchers on Letters of Credit.
- 3. The City positions of officers and employees should now include the Finance Officer, City Accounting Manager, Chief Deputy City Treasurer, and the Management Services Director.
- NOW, THEREFORE, the following City officers and employees are designated as signatories on Payment Vouchers on Letters of Credit for all Federal Granting Agencies:

City Finance Officer City Accounting Manager Chief Deputy City Treasurer Management Services Director

- Section 2. The City Auditor is hereby authorized to provide such certification as may be required to identify and attest to the name and signature and position of the person authorized by Section 1 above to sign Payment Vouchers on Letters of Credit.
- Section 3. The signatories designated by Ordinance No. 145719 are hereby terminated.
- Section 4. The Council declares that an emergency exists in order that the
