An Ordinance creating two new positions in the Bureau of Management and Budget, establishing salary rates for the current compensation plan, abolishing three positions, transferring \$7,400 in appropriation savings within the General Fund, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

- 1. At the direction of the Mayor, the Budget Officer has been implementing a change in the emphasis and workload of the Budget Office and reorganizing the staff to accomplish the work with a reduced number of positions.
- 2. The change in the organizational structure necessitates a change in authorized positions to create two new positions of Budget Analyst Supervisor (Code 830) at a flat rate of \$13.57 per hour.
- 3. The following three positions are no longer required and may be abolished:
 - 1 City Economist (Code 944)
 - 1 Principal Management Analyst (830)
 - 1 Assistant Management Analyst (826)
- 4. The new position classification and salary rate has been reviewed and approved by the Bureau of Personnel Services.
- 5. These changes in authorized positions are estimated to generate savings of \$7,400 during FY 79-80 and annual savings of \$25,700.
- 6. To increase the productivity of the staff in performing various financial analyses, a portion of the FY 79-80 salary savings from the abolished positions are required to purchase data entry equipment estimated at \$5,000.

NOW, THEREFORE, The Council directs:

(a) The following positions are hereby created in the Bureau of Management and Budget (RU 306) with salary rates as established below:
