AGREEMENT AMENDING CONTRACT NO. 18203

BUC. NO. 67000020

This agreement entered into between the City of Portland, Oregon and <u>Nutrition</u> <u>Information Center</u>, Contractor.

The parties have previously executed a contract providing for the training of CETA participants, which contract is known as Contract No. 18293. That contract should now be amended to increase contract amounts from \$12,389 to \$17,934; increase wage amounts (line item 130) from \$10,456 to \$15,139; increase fringe benefits (line item 170) from \$1,933 to \$2,795.

The parties to the contract therefore agree:

- 1. The total amount of funds in Contract No. 18293 is increased by \$5,545; FROM: \$12,389 TO: \$17,934;
- 2. The contracted wage amounts are increased by \$4,683; FROM: \$10,456 TO: \$15,139; (\$669/mon. X 7 mon.)
- 3. The contracted fringe benefit amounts are increased by \$862; FROM: \$1,933 TO: \$2,795; (18.4% of wages)
- 4. The position of Research Aide is extended to September 30, 1980, from a termination date of February 29, 1980;
- 5. The amendment is effective from March 1, 1980 and covers the period through September 30, 1980.

ORDINANCE NO. 149304

An Ordinance authorizing an amendment to Contract No. 18293 under the Human Resources Bureau, Training and Employment Division, with Nutrition Information Center; increasing contract amounts from \$12,389 to \$17,934; extending termination date of one (1) Public Service Employment position to September 30, 1980; transferring appropriations in the amount of \$5,545 within the CETA Fund; and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

- 1. The City of Portland has been designated by the United States Department of Labor as Prime Sponsor for administering funds under the Comprehensive Employment and Training Act (CETA) to provide employment and training services for unemployed persons.
- 2. Pursuant to Ordinance No. 148560 Council authorized Contract No. 18293 which initiated a CETA Title II-D program with the Nutrition Information Center for the period October 1, 1979 to September 30, 1980.
- 3. It is necessary to extend the termination date of one (1) position, Research Aide, from February 29, 1980 to September 30, 1980, to cover the duration of the contract.
- 4. It is necessary to amend Contract No. 18293 to allow for completion of the program originally authorized in October, 1979.
- 5. It is therefore necessary to increase the contract amount from \$12,389 to \$17,934 to cover participant wages and fringe benefits through September 30, 1980.
- 6. Funds are available to support this amendment under Title II-D of CETA from the Department of Labor.
- 7. It is therefore appropriate that the Mayor and Commissioner of Public Utilities execute on behalf of the City, this amendment as set out in the exhibits hereof.

a. The Mayor and Commissioner of Public Utilities execute on behalf of the City this amendment as set out in exhibits hereof.
