### Purpose of proposed legislation and background information:

The purpose of this agenda item is to appoint a Charter Commission to review and recommend amendments to the Charter.

## Financial and budgetary impacts:

- While there are no immediate financial and budgetary impacts of the appointment of Charter commissioners, Charter review will have financial and budgetary impacts.
- The Charter Commission has been funded for the 2020-2021 fiscal year.
- Charter Commission appointment terms run from December 3, 2020 to December 3, 2022.
- The Charter Commission will require funding in the 2021-2022 fiscal year and the 2022-2023 fiscal year.
- The Office of Management & Finance will provide primary staffing to the Charter Commission.
- Adequate funding and capacity for community engagement for the required Charter review process is essential for ensuring outreach to all Portlanders and gathering broad public input to inform proposed Charter amendments.
- The upcoming 2021-2022 budget process should ensure ongoing adequate funding for the Charter Commission.
- While we do not know what, if any, Charter amendments the Charter Commission will recommend, it is possible that Charter reform may create long-term financial impacts for the City.

## **Community impacts and community involvement:**

- All Portlanders may be impacted by the Charter review process.
- Charter amendments recommended by the Charter Commission may go before voters and result in changes to our City Charter.
- Public involvement and input are essential to this process.
- Charter review provides the opportunity for civic engagement and community involvement in the workings of our government.
