S.W. 22nd Ave. No. 1694 and 1729, from S.W. Spring

Garden Street northerly to S.W. Multnomah Blvd.

S.W. Multnomah Blvd. No. 1491 and 1491 A from S.W. Barbur Blvd. near S.W. 12th Ave. westerly to the City boundary at S.W. 37th Ave.

WHEREAS, a warrant in the sum of \$18,000.00, drawn by the County Auditor, payable to the City of Portland has been placed in the Trustee Fund of the City of Portland for the improvement of and/or maintenance of said streets, and

WHEREAS, no award of damages and no assessment of benefits has been sustained by anyone, and it appears to the Council that all of said County roads should be laid out, taken over and established as City streets; now therefore,

S.W. Multnomah Blvd. No. 1491 and 1491A from S.W. Barbur Blvd. near S.W. 12th Ave. westerly to the City boundary at S.W. 37th Ave.;

be and the same are hereby taken over, laid out and established as City streets, and the City of Portland, from this date forward shall have exclusive jurisdiction and control over said County roads.
