## ORDINANCE NO. 149316

An Ordinance granting a revocable permit to the Shrine Circus permitting the use of the Memorial Coliseum parking lot for the storage of circus equipment and trailers for living purposes for the three-day duration of the circus, and declaring an emergency.

The City of Portland ordains:

#### Section 1. The Council finds:

- 1. That the Shrine Circus will be playing at the Coliseum from March 27, 1980, through March 30, 1980.
- 2. That City Code Section 8.32.120 permits camping or recreational vehicles to be parked on the parking lot of the Memorial Coliseum complex in order to provide living quarters for persons caring for animals involved in shows at the Coliseum.
- 3. That it is desirable that the Coliseum parking lot use be expanded to permit all circus personnel and equipment to use the parking lot to place living trailers and equipment on for the three-day term of the Shrine Circus.
- Section 2. That this action has been approved by the Coliseum manager;

### NOW, THEREFORE, The Council directs:

- a. The revocable permit is hereby issued to the Shrine Circus allowing the Memorial Coliseum parking lot to be used for the parking of living trailers for the Shrine circus personnel and permitting the storage of circus equipment.
- b. This permit is granted from March 26, 1980, through March 30, 1980.
- c. This permit is granted on the condition that the permittee shall upon termination clean the parking lot of the Memorial Coliseum to the satisfaction of the City.

## ORDINANCE No.

Section 3. The Council declares:

That an emergency exists in order that an irrevocable permit be issued without delay to the Shrine Circus permitting the use of the Memorial Coliseum parking lot for the storage of circus equipment; therefore, this ordinance shall be in full force and effect from and after its passage by the Council.
