ORDINANCE No. 149317

An Ordinance authorizing the Purchasing Agent to call for bids to furnish material and labor to construct the Improvement of NW Wilson St. from NW 23rd Ave. to NW 24th Ave. and NW Roosevelt St. from NW 21st Ave. to NW 22nd Ave. in Northwest Portland for the Bureau of Street & Structural Engineering, authorizing a contract, authorizing the drawing and delivery of warrants and declaring an emergency.

The City of Portland Ordains:

Section 1. The Council finds:

- 1. That \$162,512 was approved in the Bureau of Street & Structural Engineering's budget for FY 1979-80 to construct local streets in the Northwest Industrial Area.
- 2. That the proposed projects will serve to enhance industrial access and provide additional on-street parking.

NOW, THEREFORE, The Council directs:

- a. The Purchasing Agent shall advertise for bids using specifications filed in his office and in the event that no satisfactory bid is received, shall readvertise on the same basic specifications until a satisfactory bid is received.
- b. A contract is authorized with the most favorable bidder as designated by the Council.
- c. The Mayor and the Auditor hereby are authorized to draw and deliver warrants chargeable to the 1979-1980 General Fund, Bureau of Street & Structural Engineering, BUC #15900253, Object Code 630, when demand is presented, approved by the proper authority.

Section 2. The Council declares:

An emergency exists because a delay in proceeding with the purchase may result in additional expense, and will unnecessarily deprive the City of the benefits of completion of the contract at an early date; therefore, this ordinance shall be in force and effect from and after its passage by the Council.
