

RESOLUTION NO. 28546

WHEREAS, it appears to the Council that Multnomah County, Oregon, by its Commissioners, entered final orders dated March 14, 1961, surrendering to the City of Portland its jurisdiction over all that portion of each of the five Multnomah County roads, lying within the corporate limits of the City of Portland and described as follows:

1. N. Smith Street (County Road No. 480) between N. Oswego Avenue and N. Columbia Boulevard.
2. N. Columbia Boulevard (County Road No. 480) between N. Fairhaven Avenue and N. Fessenden Street.
3. N. Richmond Avenue (County Road No. 613) between N. Jersey Street and N. Edison Street.
4. N. Burlington Avenue (County Road No. 317) between the Willamette River and N. Edison Street.
5. N. Syracuse Street (County Road No. 613) between N. Leavitt Avenue and N. Richmond Avenue.


WHEREAS, no award of damages and no Assessment of Benefits has been sustained by anyone and it appears to the Council that all of said County roads should be laid out, taken over and established as City streets, now, therefor

BE IT RESOLVED, by the Council of the City of Portland, Oregon, that all that portion of each of the five Multnomah County roads, lying within the corporate limits of the City of Portland, be and the same are hereby taken over, laid out and established as City streets and the City of Portland from this date forward shall have exclusive jurisdiction and control over said County Roads as follows:


1. N. Smith Street (County Road No. 480) between N. Oswego Avenue and N. Columbia Boulevard.
2. N. Columbia Boulevard (County Road No. 480) between N. Fairhaven Avenue and N. Fessenden Street.
3. N. Richmond Avenue (County Road No. 613) between N. Jersey Street and N. Edison Street.
4. N. Burlington Avenue (County Road No. 317) between the Willamette River and N. Edison Street.
5. N. Syracuse Street (County Road No. 613) between N. Leavitt Avenue and N. Richmond Avenue.

BE IT FURTHER RESOLVED, that the City Auditor forward copies of this Resolution to the County Commissioners of Multnomah County, the County Roadmaster and the County Assessor.
