## **COMPLAINT**

Violations of Contribution Limits by Friends of Ted Wheeler

- Complainants David Delk, Ron Buel, Moses Ross, and Seth Woolley, residents of Portland, file this Complaint alleging violations of the campaign contribution limits of Portland Charter Chapter 3, Article 3, and Portland City Code Chapter 2.10 ("Portland Campaign Contribution Limits") by Friends of Ted Wheeler, the principal campaign committee of his campaign for Mayor of Portland.
- 2. The Portland Campaign Contribution Limits were enacted as party of Measure 26-200 of 2018.
- 3. This Complaint is pursuant to Portland Charter § 3-305.
- 4. Portland Charter § 3-302 sets forth the Portland Campaign Contribution Limits:

## 3-302 Contributions in City of Portland Candidate Elections.

- (a) An Individual or Entity may make Contributions only as specifically allowed to be received in this Article.
- (b) A Candidate or Candidate Committee may receive only the following Contributions during any Election Cycle:
  - (1) Not more than five hundred dollars (\$500) from an Individual or a Political Committee other than a Small Donor Committee:

- (2) Any amount from a qualified Small Donor Committee;
- (3) A loan balance of not more than five thousand dollars (\$5,000) from the candidate;
- (4) No amount from any other Entity, except as provided in Section 3-304 below.
- 5. These contribution limits went into effect on September 1, 2019, pursuant to Portland Charter § 3-305(a). No court has enjoined the implementation of the Portland Campaign Contribution Limits.
- 6. The City Auditor has refused to enforce these contribution limits, except for contributions made on or after May 4, 2020. Measure 26-200 does not allow the City Auditor to create exemptions from the Portland Campaign Contribution Limits.
- 7. Since November 14, 2019, Friends of Ted Wheeler has received 78 contributions in apparent violation of the contribution limits, as listed on Exhibit 1 from the ORESTAR system maintained by the Oregon Secretary of State.
- 8. The latter 66 of those contributions have not previously been the subject of a complaint to the City Auditor.
- 9. The listed contributions by individuals are in excess of the \$500 per individual per election cycle limit.
- 10. The listed contributions by Political Committees are in excess of the \$500 per Political Committee per election cycle limit.
- 11. The listed contributions by corporations and unions are in violation of the prohibition on contributions by all entities other than Political Committees and Small Donor Committees.
- 12. The \$500 contribution on May 8, 2020, from Oregon AFSCME Council 75 violated the prohibition on contributions by all entities (non-individuals) other than Political Committees and Small Donor Committees.

- 13. The \$500 contribution on May 18, 2020, by Daniel Petrusich comprises a violation of the limit on individual contributions per Election Cycle, as the donor has previously contributed \$1,000 to the Friends of Ted Wheeler during the current election cycle.
- 14. Complainants demand that the City Auditor apply the fines required by Portland Charter § 3-305(b): "a civil fine which is not less than two nor more than twenty times the amount of the unlawful Contribution or Expenditure or Independent Expenditure at issue."
- 15. Complainants request that the City Auditor conduct an audit of all contributions of \$100 or less received by Friends of Ted Wheeler to ensure that only legal contributions are being reported under that label.
