Yes, in accordance with the dates in question, the list of top five contributors is correct.

We appreciate your review and proposed update of our written disclaimer. We have updated our online and other materials with this language per your recommendation, pending additional review of the suggested July, 2016 start date for the current election cycle.

We believe this date is erroneous since Mayor Wheeler was not sworn into office until January, 2017. This seems like the obvious and recognizable start date for a re-election campaign, since the certification of a primary election is neither a publicly known date, nor does it signify the beginning-- or end-- of a term in office.

But while we explore this issue further, we will be in compliance with this date, and appreciate your input as we all navigate these new rules and requirements.

In doing an audit of Friends of Ted Wheeler's top five dominant contributors for the current election cycle, the City Elections Office has determined a different list of the top dominant contributors than what was provided:

- 1. Local 48 Electricians PAC contributed an aggregate of \$65,000 between 7/6/2016 and 5/14/2020.
- 2. SEIU Local 49 contributed an aggregate of \$29,000 between 7/6/2016 and 5/14/2020.
- 3. Melvin Mark Properties LLC contributed in-kind donations totaling \$16,830 between 7/6/2016 and 5/14/2020.
- 4. Portland Metro Firefighters PAC contributed an aggregate of \$12,500 between 7/6/2016 and 5/14/2020.
- 5. Melvin Mark Brokerage Co. contributed in-kind donations totaling \$12,434.94 between 7/6/2016 and 5/14/2020.

No later than Wednesday, July 22, 2020 (7/22/2020), please confirm whether the contributors the City Elections Office found are the true top five dominant contributors for Friends of Ted Wheeler. If not, please provide the campaign's top five dominant contributors for the current election cycle.

For each of the top five dominant contributors, please also include the types of businesses where the contributors received a majority of income over the last five years. If any of the dominant contributors is a political committee, please include that committee's top 3 funders during the current election cycle.

As a reminder, the City's campaign regulations define <u>election cycle</u> as "the period between an election at which a candidate is elected and the next election for that same office, disregarding any interfering primary or nominating election, any recall election, or any special election called to fill a vacancy." For mayoral candidate Ted Wheeler, his election cycle began the <u>day the City certified the 2016 primary election results</u>. Also, <u>per the City's</u> <u>campaign disclosure regulations</u> and <u>administrative rules on disclosure requirements</u>, electronic communications must be current to within five business days of an electronic communication.
