  - a. The names of businesses from which the contributors earned a majority of their income over the last five years, with each business identified with the name associated with its six-digit code of the NAICS;
  - b. Or, if any of the top dominant contributors is a political committee or nonprofit, please list their top three funders during the current election cycle.
