ORDINANCE No. 149324

An Ordinance revising salary rates in the Compensation Plan for Parks Equipment Foreman and Parks Maintenance Mechanic Foreman, Bureau of Parks, effective January 1, 1980, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

- 1. The responsibilities of the Parks Equipment Foreman and Parks Maintenance Mechanic Foreman in the past year have expanded in the amount of equipment and personnel managed in the diverse responsibilities for operator and safety training, and in the independence of action they exercise in providing services to the entire Bureau.
- 2. A review of the salary rates for Parks Equipment Foreman and Parks Maintenance Mechanic Foreman concludes that they should be reviewed to reflect the current levels of responsibility, to be effective retroactively to January 1, 1980.
- 3. The changes have been recommended by the Bureau of Personnel Services.
