

ORDINANCE NO. **149326**

An Ordinance authorizing the drawing and delivery of warrants in the sum of \$2,280.00 payable to Hollywood Lights, and \$225.00 payable to Rose City Sound for providing technical equipment to the Civic Auditorium, authorizing the transfer of appropriation in the amount of \$2,505.00 from the Auditorium Operating Contingencies to the Auditorium Fund, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

1. The Bureau of Civic Auditorium requires \$2,505.00 additional appropriation in the Auditorium Fund for the purchase of eighteen Ellipsoidal Spotlights and a microphone mixer.
2. The Ellipsoidal Spotlights were part of a lease purchase agreement entered into by the City of Portland for a 3 month period beginning August 20, 1979 and ending November 19, 1979. The microphone mixer was loaned to the Civic Auditorium in an emergency on October 1, 1979.
3. The 18-360 Quartz 16 x 22 Ellipsoidal Spotlights with NEMA #15p Connector, C clamps and Color frames were installed prior to the theatre season to provide better lighting on stage. The Shure M67 Microphone mixer was installed to operate the house chimes and inter-office paging system.
4. Both pieces of equipment are necessary for continued successful operation of theatrical productions.
5. These purchases have been reviewed and approved by the Purchasing Agent. It is therefore in the public interest for Hollywood Lights and Rose City Sound to be paid for their respective equipment.
6. The additional appropriation should be provided by transfer from the Auditorium Operating Contingencies to Auditorium Capital Outlay.

NOW, THEREFORE, The Council directs:

- a. The Purchasing Agent shall sign Purchase Orders to serve

as contracts with Hollywood Lights, 0625 S.W. Florida St., Portland, Oregon 97219, and with Rose City Sound, 1925 S.E. Morrison St., Portland, Oregon 97214 in the amounts of \$2,280.00 and \$225.00 respectively.

- b. The Mayor and the Auditor hereby are authorized to draw and deliver warrants chargeable to the 1979-80 Budget; Fund 11, Civic Auditorium, RU 333, BUC #333-00051, Object Code 640.
- c. \$2,505.00 is transfered within the Auditorium Fund, from Auditorium Operating Contingencies, RU 334, BUC #33400209, Object Code 710, to the Auditorium Appropriation Unit, RU 333, BUC #33300051, Object Code 640.

Section 2. The Council further directs:

The Council declares an emergency exists because a delay in proceeding with this transfer may result in additional expense to the City; therefore, this Ordinance shall be in force and effect from and after its passage by the Council.
