

ORDINANCE NO. 149329

An Ordinance abolishing a Senior Steno Clerk position and creating the position of Clerk III in the Office of Justice Planning and Evaluation and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

1. The staff of the Portland Civil Service Board has reviewed one position in the Office of Justice Planning and Evaluation.
2. As a result of that review the staff has recommended that the position of Senior Stenographer Clerk be reclassified to a Clerk III.
3. The Civil Service Board has approved the recommended reclassification.
4. The rate of pay for the reclassified position is in the current City of Portland Compensation Plan.

NOW, THEREFORE, the Council directs:

- a. The following position is abolished in the Office of Justice Planning and Evaluation.

The Council declares that an emergency exists because the position to be created is required immediately in order that the functions may be carried out without delay and the position to be abolished should not be continued unnecessarily; therefore, this Ordinance shall be in force and effect from and after its passage by the Council.
