

ORDINANCE No. 149331

An Ordinance creating 1 position of Senior Stenographer Clerk and abolishing 1 position of Steno Clerk in the Bureau of Water Works, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

1. 1 position of Senior Stenographer Clerk is required by the Bureau of Water Works.
2. The duties required of this position are as described for a Senior Stenographer Clerk.
3. 1 position of Steno Clerk can be abolished to provide appropriation for the position being created.
4. The change has been approved by the Bureau of Personnel Services.

NOW, THEREFORE, the Council directs:

- a. The following position is created in the Bureau of Water Works, with salary rates in accordance with the current Compensation Plan:


- b. The following position in this bureau is abolished:

1	0220	Stenographer Clerk


