

An Ordinance creating one position of Principal Accountant and abolishing one position of Senior Accountant in the Office of General Services, effective immediately, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

1. One position of Principal Accountant is required by the Office of General Services.
2. The reclassification of a Senior Accountant position is necessary because a review of the position by the Bureau of Personnel Services indicates the duties and responsibilities are those of a Principal Accountant, as per Exhibit "A" attached hereto.
3. The necessary additional appropriation is available in the Personal Services budget of the Office of General Services.
4. The change has been approved by the Bureau of Personnel Services.

NOW, THEREFORE, The Council directs:

- a. The following position is created in the Office of General Services, with salary rates in accordance with the current Compensation Plan:
