

## RESOLUTION NO. 30545


WHEREAS, it appears to the Council that proceedings should be taken pursuant to O.R.S. 271.130 for the vacation of certain portions of S.W. Moody Avenue and S.W. Grover Street in the corporate limits of the City of Portland,

RESOLVED, that proceedings be and they are hereby initiated by the Council of the City of Portland, Oregon, for the vacation of the above-mentioned streets hereinafter described; that the City Auditor be and he is hereby directed to give notice as provided by law for such vacations and the City Engineer is hereby directed to interview the abutting property owners and obtain from them their consent to such vacation, if they are willing to give it, such consent to be in writing and acknowledged before a Notary Public and to be filed with the City Auditor; that 9:30 o'clock a.m., Wednesday JUL 30 1969 in the Council Chamber of the City Hall, Portland, Oregon, be and the same is hereby fixed as the time and place for a hearing upon the contemplated vacations of said streets and upon all objections, remonstrances and/or claims for damages that may be presented and filed with the City Auditor prior to that time; that the contemplated use of said street areas in the event of such vacation shall be for commercial purposes; that a particular description of said streets contemplated for vacation is as follows:

Those portions of S.W. Moody Avenue and S.W. Grover Street lying within the following described area:

Beginning at a point on the south line of Block 120 as shown on the duly recorded plat, Caruthers Addition, that is 60.00 feet easterly of the southwest corner of said block; thence North, assumed bearing, parallel to said west block line and its northerly extension a distance of 260.0 feet to a point in the south line of Block 100 in said Caruthers Addition; thence S. 5° 58' 50" W. a distance of 217.46 feet to a point of curve; thence along the arc of a 24.35 foot radius curve to the left having a central angle of 38° 16' 21" a distance of 16.27 feet (chord bears S. 13° 09' 20" E. a distance of 15.96 feet); thence S. 32° 17' 31" E. a distance of 24.85 feet; thence S. 38° 43' 26" E. a distance of 9.18 feet to the point of beginning, and also:

S.W. Grover Street from the northerly extension of a line drawn 60.0 feet easterly of and parallel to the west line of said Block 120 to the northerly extension of the easterly line of said Block 120.
