all being within the corporate limits of the City of Portland, County of Multnomah and State of Oregon.

WHEREAS, no awards of damages and no assessment of benefits have been sustained by anyone, and it appears to the Council that all of said County Road should be laid out, taken over and established as a City street, now therefore,

BE IT RESOLVED, by the Council of the City of Portland, Oregon, that all that portion of

SE 105th Avenue No. 695 from Mt. Scott Blvd. northerly to SE Knapp Street, in the west half of Section 22, T1S, R2E, W.M., all that portion of SE Knapp Street No. 695 from SE 105th Avenue westerly to SE 100th Avenue in the northwest quarter of Section 22, T1S, R2E, W.M., and the northeast quarter of Section 21, T1S, R2E, W.M., all that portion of SE 100th Avenue No. 695 from SE Knapp Street northerly to SE Woodstock Court in the northeast quarter of Section 21, T1S, R2E, W.M. and the southeast quarter of Section 16, T1S, R2E, W.M., and all that portion of SE Woodstock Court No. 695 from SE 100th Avenue northwesterly to SE Foster Road, in the southeast quarter of Section 16, T1S, R2E, W.M.

be and the same is hereby taken over, laid out and established as a City street and the City of Portland from this date forward shall have exclusive jurisdiction and control over said County Road.

BE IT FURTHER RESOLVED, that the City Auditor forward copies of this Resolution to the County Commissioners of Multnomah County, the Director of Public Works, and the County Assessor.
