ORDINANCE No.

149353

An Ordinance creating three positions of Clerk II and abolishing one position of Senior Stenographer Clerk and two positions of Typist Clerk in the Bureau of Police, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

- 1. That three positions of Clerk II are required by the Bureau of Police.
- 2. Civil Service has determined that the job requirements are those of a Clerk II in lieu of a Senior Stenographer Clerk and the Typist Clerks.
- 3. Two Typist Clerk positions and one Senior Stenographer Clerk position can be abolished to provide partial appropriation for the positions being created.
- 4. The necessary additional resources will be provided from the Bureau's Personal Services appropriation for Part-Time.
- 5. The appropriate classifications should therefore be made.

NOW, THEREFORE, the Council directs:

a. Three (3) positions of Clerk II (0112) are hereby created with salary rates in accordance with the current Compensation Plan and two (2) positions of Typist Clerk (0210) and one (1) position of Senior Stenographer Clerk are abolished within the Bureau of Police.

Section 2. The Council declares that an emergency exists because the positions to be created are immediately required in order that the new functions may be carried out without delay and the positions to be abolished should not be continued unnecessarily; therefore, this Ordinance shall be in force and effect from and after its passage by the Council.
