ORDINANCE No. 149362

An Ordinance transferring \$2,000 in appropriations within the General Fund from the Bureau of Police to the Office of the City Attorney and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

- 1. That the Bureau of Police requires an intensive, professional review of the legal issues involved in police records management.
- 2. That the City Attorney has agreed to perform this project for the Bureau of Police.
- 3. That the additional resources required by the Office of the City Attorney will be provided from savings in Personal Services by the Records Division of the Police Bureau.
- 4. That it is, therefore, necessary to transfer \$2,000 from the Bureau of Police to the Office of the City Attorney.

NOW, THEREFORE, the Council directs:

a. That appropriations be transferred between appropriation units within the General Fund in accordance with the following:


