**ORDINANCE No. 149372**

An Ordinance authorizing a refund in the amount of \$1,200.00 to Richard A. Henderson and Nova J. Heyduck, deedholders of Tax Lot '120', Section 3, T1N, R1E, W.M., authorizing the drawing and delivery of a warrant and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

1. That Tax Lot '120' Section 3, T1N, R1E, W.M., was assessed \$2,317.26 for the construction of N.E. Gertz Road and N. Schmeer Road Sanitary Sewer System. A drafting error in the as built plans resulted in an overcharge of \$1,200.00.
2. The total assessment of \$2,317.26 was paid and a refund is necessary to correct the overcharge.

NOW, THEREFORE, the Council directs:

The Mayor and Auditor are hereby authorized to draw and deliver a warrant in the amount of \$1,200.00 to Richard A. Henderson and Nova J. Heyduck, 3025 N. Farragut Street, Portland, Oregon 97217, chargeable to BUC No. 43300016/490.


Section 2. The Council declares that an emergency exists because delay would result in cost and inconvenience to the property owner; therefore, this ordinance shall be in force and effect from and after its passage by the Council.

2. The total assessment of \$2,317.26 was paid and a refund is necessary to correct the overcharge.


NOW, THEREFORE, the Council directs:
