## ORDINANCE NO. 149378

An Ordinance authorizing the creation of thirty (30) positions within the Human Resources Bureau for the period beginning April 1, 1980 and ending September 30, 1980; creating thirty (30) Public Service Employment positions under CETA Title VI Special Projects; transferring appropriations within the CETA Fund in the amount of \$185,507; and declaring an emergency.

The City of Portland ordains:

#### Section 1. The Council finds:

- 1. The City of Portland has been designated by the U. S. Department of Labor as Prime Sponsor for administering funds under CETA Title VI to provide employment and training opportunities for unemployed persons.
- 2. The Human Resources Bureau is requesting authorization to utilize thirty (30) CETA Title VI Special Project positions to augment the Training and Employment Division's Youth Career Training Unit and the Youth Summer Employment Program, providing employment services through the community based Youth Career Training Area Offices.
- 3. These positions will be entry level and afford training and transition potential within the general program of the Training and Employment Division.
- 4. Funds in the amount of \$4,000 are to be provided to support the costs of local travel in conjunction with this program.
- 5. The positions requested have the approval of the Training and Employment Division's Program Development Unit, Youth Career Training Program Director, the Training and Employment Division Manager, and the Executive Director of the Human Resources Bureau.
- 6. Funds are available within the CETA Fund in the Fiscal Year 1979-80 Budget to provide for the cost of positions created herein.
- 7. The period from July 1, 1980 through September 30, 1980 is contingent upon FY 1980-81 Budget approval by the City Council.
- 8. The positions and their costs are set out in Attachment "A".

### NOW, THEREFORE, the Council directs:

a. That thirty (30) CETA Title VI Special Project positions be created in the Human Resources Bureau.
