ORDINANCE NO. 149387

An ordinance authorizing the transfer of an appropriation of \$50,000 within the General Fund for the purchase of parking meter coin vault locks, abolishing one Parking Meter Technician position, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

- 1. The Bureau of Maintenance requires \$50,000 for the purchase of parking meter coin vault locks.
- 2. The replacement of present meter locks with an improved design will reduce maintenance costs by \$30,600 per year.
- 3. The Bureau of Maintenance, Traffic Maintenance Section, will require one less Parking Meter Technician, due to the reduced lock maintenance activity.
- 4. The needed appropriations should be provided from the existing budget of the Bureau of Maintenance.

NOW, THEREFORE, the Council directs:

a. The 1979-80 City Budget is hereby amended to change appropriations as follows:

Section 2. The Council further directs:

a. One (1) Parking Meter Technician position, Class #1250, is abolished in the Bureau of Maintenance, Traffic Maintenance Section.

Section 3. The Council declares that an emergency exists because the appropriation is needed immediately in the accounts to which they are to be transferred so that there may be no program interruption or administrative delay. The position to be abolished should not be continued unnecessarily; therefore, this ordinance shall be in force and effect from and after its passage by the Council.
