ORDINANCE No. 149399

An Ordinance authorizing application to the Department of Housing and Urban Development for a grant under Title I of the Housing and Community Development Act of 1974 as amended in the amount of \$10,356,000 for fiscal year 1980-81; authorizing a contract and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds that:

- 1. Title I of the Housing and Community Development Act of 1974 which was reauthorized in 1977 provides that the Secretary of Housing and Urban Development may make Community Development Block Grants to local public bodies;
- 2. The Council has reviewed the Annual Program Summary at a public hearing held on March 26, 1980.
- 3. General Fund dollars are not required as match for this grant.
- 4. It is appropriate and in the public interest that the Mayor be authorized to apply for and receive funds for such a grant.

NOW, THEREFORE, the Council directs:

- a. The Mayor is authorized to apply to the Department of Housing and Urban Development on behalf of the City of Portland for a Community Development Block Grant in an amount estimated to be \$10,356,000.
- b. A contract with the Department of Housing and Urban Development for this grant is authorized.
- c. The Mayor is authorized to provide such assurances and information to the Department of Housing and Urban Development as may be required for application and orderly management of the grant.

Section 2. The Council declares an emergency exists so that the grant funds as described in Section 1 hereof may be available without undue delay; therefore, this Ordinance shall be in force and effect from and after its passage by Council.
