ORDINANCE NO. 149416

An Ordinance authorizing the transfer of \$14,000 within the General Fund, from the General Operating Contingency to the Bureau of Fire (AU 124) for the purchase of foam, and declaring an emergency.

1

The City of Portland ordains:

Section 1. The Council finds:

- 1. That the Fire Bureau applied its total stock of AFFF agent foam (1,140 gallons) to a gasoline spill which occurred on March 14, 1980 at the Chevron Tank Farm.
- 2. That in order to meet the demand for foam at the scene of the spill and to replenish its on-hand stock of foam the Fire Bureau initiated emergency purchase actions for an additional 1,135 gallons of foam at a cost of \$14,575.
- 3. That to date the Bureau of Fire has expended approximately \$29,000 for foam which is \$14,000 greater than its budget allocation of \$15,000.
- 4. That the Bureau of Five does not have sufficient Materials and Services appropriation to absorb this additional expenditure thereby necessitating the transfer of \$14,000 from the General Operating Contingency.


