

ORDINANCE No. 149420

An Ordinance repealing Ordinance No. 149193 which declared the buildings at 509 N.E. Skidmore Street to be a public nuisance pursuant to Chapter 24.55 of the Code of the City of Portland and providing abatement by removal, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

1. On February 20, 1980, Ordinance No. 149193 was passed declaring the building at 509 N.E. Skidmore Street more particularly described as E. 33 1/3' of W. 66 2/3' of S. 7' of Lot 5 and E. 33 1/3' of W. 66 2/3' of Lot 6, Block 2, Lincoln Park Annex in the City of Portland, Multnomah County, Oregon to be a public nuisance and providing abatement by removal.
2. The building has recently been sold and the new owner plans to start rehabilitation in the immediate future.

NOW, THEREFORE, The Council directs:

- a. Ordinance No. 149193 is repealed in its entirety.


Section 2. The Council declares:

That an emergency exists because delay in the enactment of this ordinance could result in unnecessary action by the Director of the Bureau of Buildings in abatement of the nuisance. Therefore, this ordinance shall be in force and effect, from and after its passage by Council.
