ORDINANCE No. 149423

An Ordinance authorizing use of Eastmoreland Golf Course for the City Championship Tournament, July 13-19, 1980, establishing greens fees, notwithstanding provisions of Section 20.20.010 of the City Code, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

- 1. The City of Portland has jointly sponsored the City Championship Golf Tournament every year since 1918, making it one of the oldest major tournaments in the area.
- 2. The 1980 City Championship is scheduled to be held at Eastmoreland Golf Course on July 13-19, 1980. Special green fees for this event are set, with 50% being paid to the City and 50% being used for prizes for the contestants and tournament expenses.
- 3. The exposure resulting from this tournament would be beneficial in promoting and publicizing the City's golf program and such use has been approved by the Commissioner in charge of the Bureau of Parks.

NOW, THEREFORE, the Council directs:

a. Use of Eastmoreland Golf Course is authorized for the City Championship Tournament on July 13-19, 1980, with green fees set as follows, notwithstanding provisions of section 20.20.010 of the City Code:

\$35.00 - Men

\$30.00 - Seniors

50 percent of such greens fees collected for the tournament shall be paid to the City and the remaining 50 percent of green fees shall be retained by the City Championship Tournament Committee for expenses of operation of the tournament, awards, and other expenses.

Section 2. The Council declares that an emergency exists because delay in enactment of this ordinance would cause unnecessary difficulty in making arrangements for the tournament; therefore, this ordinance shall be in force and effect from and after its passage by the Council.
