## ORDINANCE NO. 149432

An Ordinance granting a park-use permit to Portland Inter-Tribal Club to use the area from the restrooms west at East Delta Park for the Rose Festival Inter-Tribal Pow-Wow and Encampment from June 9 through June 18, 1980, under certain conditions and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

- The Portland Inter-Tribal Club by Terry Fast Horse, 1634 S.W. Alder Street, Portland, Oregon desires to use the area from the restrooms west at East Delta Park for the Rose Festival Inter-Tribal Pow-Wow and Encampment from June 9, 1980 through June 18, 1980.
- 2. The application has been approved by the Superintendent of Parks and the Commissioner in charge of the Bureau of Parks.

NOW, THEREFORE, the Council directs:

- 1. A park-use permit hereby is granted to Portland Inter-Tribal Club to use the area from the restrooms west at East Delta Park for the Rose Festival Inter-Tribal Pow-Wow and Encampment from June 9 through June 18, 1980.
  - a. The permit hereby granted shall be revocable at the pleasure of the Commissioner in charge and no expenditure of money hereunder or lapse of time or any act or thing shall operate as an estoppel against the City of Portland, or be held to give the permittee any vested or other right.
  - b. The permit hereby granted is personal to the permittee and may not be sold, assigned, or otherwise transferred by permittee or operation of law.
  - c. No area of the Park may be used for spectator viewing, operation of concessions or parking of automobiles without specific approval of that use by the Superintendent of Parks.
  - d. Permittee hereby agrees to provide volunteer service to prepare and/or repair East Delta Park for their Inter-Tribal event, and by his/her own expense will clean up all debris resulting from use of Park area, and return the Park area used in as good condition as it was immediately prior to permittee's use.
  - e. Amplified guitars and rock music are prohibited.
