SUBJ: Third Amendment to the Downtown Waterfront

Urban Renewal Plan

In accordance with Oregon Revised Statutes (ORS) 457 the Portland Development Commission has requested that the Portland City Planning Commission review a proposed Third Amendment to the Downtown Waterfront Urban Renewal The purpose of this review is to determine whether this amendment conforms with the General Plan for Downtown

The Planning Commission, at its September 7, 1977 meeting, reviewed the Third Amendment and recommended:

- Approval of the Third Amendment language changes as indicated in the August 26, 1977 Portland Development Commission draft calling for the acquisition of Block R.
- 2. That language be added to the Third Amendment establishing a Transportation Center District bounded by NW Broadway, NW Front, NW Glisan and NW 5th Avenue.

Attached are the findings on which this action is based and a copy of the previous Planning Commission action on this proposal to consolidate inter-city bus facilities in the Union Station area.

3rd Amendment to Waterfront Urban Penewal Plan

Staff Report

At the direction of City Council, the Portland Development Commission has prepared a new 3rd Amendment to the Urban Renewal Plan for the Downtown Waterfront Urban Project (see attached August 26, 1977 letter, Council Resolution 31934 August 25, 1977, and 3rd Amendment draft).

A previous 3rd Amendment draft approved by the Planning Commission on October 5, 1976 was not processed through the City Council because of Greyhound's decision not to build.

The Urban Renewal Plan document, as amended, provides for Planning Commission review of Plan Amendments prior to action by the City Council. Accordingly, the Development Commission has requested such review of the new 3rd Amendment draft to verify that the proposed language is in accord with the adopted Downtown Plan and Parking and Circulation Policy.

History of Planning Commission and City Council Action

- On May 20, 1975 the Planning Commission recommended that relocation of the two inter-city bus companies into a joint facility proceed immediately and that the Union Station area (Broadway, Front, and Glisan) is deemed to most desirable location for such a facility.
- 2. On September 17, 1975 the City Council by Resolution No. 31601 adopted the above recommendations and authorized the Development Commission to enter into such additional studies and negotiations as may be necessary to initiate such a project and location options, financing, and timing recommendations be returned to City Council.
- 3. On October 5, 1976 the Planning Commission recommended approval of a previous 3rd Amendment draft calling for: the acquisition of Block V (bounded by 5th, 6th, Hoyt, and Irving) for Transportation Center use; the vacation of NW Hoyt between 5th and 6th; and the establishment of a "Transportation Center" district in the Urban Renewal Project area.
- 4. On March 1, 1977 the Planning Commission approved the DPR 62 application of Mt. Hood Stages/Pacific Trailways to construct a terminal on the south half of Block R (bounded by Broadway, 6th, Glisan, and Hoyt). Also, on June 21, 1977 the Commission approved the DPR 65 application of the Portland Development Commission on behalf of Greyhound to construct a terminal, etc. on a tract comprised of Blocks V and Q and the vacated Hoyt Street (bounded by 5th, 6th, Irving, and Glisan). This approval included other recommendations on package express access location



- and truck routing and preparation of a development program to include parking, sidewalk improvements, Tri-Met facilities, etc.
- 5. On August 25, 1977 by Resolution No. 31934 the City Council in part authorized PDC to negotiate an extension of the option to purchase Block V (north block), negotiate with Trailways for possible acquisition of Block R (west block) and lease back to Trailways for a temporary terminal and that PDC request Multnomah County to hold Block Q (east block) for possible inclusion in a Transporation Center.

Findings and Conclusions

- 1. The language changes proposed in the new 3rd Amendment, providing for acquisition of Block R for "Transportation Center" use, is in accord with the adopted "General Plan" for the downtown area and previous Commission recommendations and City Council actions.
- 2. The language and Map 4 change contained in the previous 3rd Amendment draft approved by the Planning Commission October 5, 1976, establishing a "Transportation Center" district should be included in the current draft in order to verify further the City's intent that Transportation Center and related development should be undertaken in this area. Such district should be defined for Broadway, Glisan, Front, and Fifth Avenue. If this district is now established, any further plan amendments calling for PDC property acquisition would not then be regarded as major amendments and would not require review by the Planning Commission.


The Urban Renewal Plan for the Downtown Waterfront Urban Renewal Project, approved by the City Council of the City of Portland by Resolution No. 31395, adopted on April 25, 1974, which Plan has been amended and, as amended, approved by the City Council by Resolution No. 31580 adopted June 11, 1975, and Resolution No. 31694 adopted May 27, 1976, and, as amended, is recorded in Book 1107 at pages 308 through 337, inclusive, of the Deed Records of Multnomah County, Oregon, and is hereby further amended as follows:


- 1. Section C 2.b. is hereby amended by changing the subsection designation from "b." to "c." and the subsection heading to read as follows:
 - "c. Plan and Design Review."
- 2. Section C 2.b. is hereby further amended by substituting a new Subsection "b" to read as follows:
 - "b. Transportation Center
 The Transportation Center, as identified on the Districts Map. (Exhibit Four Part Two), shall be developed to provide for efficient concentration of the interstate bus companies and related uses in proximity of other transportation facilities. Development of the Transportation Center shall comply with Title 33, Planning and Zoning Code of the City of Portland, and shall be supportive of the objectives of this Plan."
- 3. Exhibit 4 is hereby amended by deleting the word "historic" from the exhibit title and legend and by adding a new district on the map and in the legend to be designated as follows: "Transportation Center". See attached amended Exhibit 4.
- 4. Section D 2.c. is hereby amended by adding a line under "Parcel" and "Intended Use" to read as follows:

"Parcel 3

Transportation Center"

5. Exhibit 5 is hereby amended by adding an additional parcel to be acquired shown on the map as the block bounded by NW Glisan Street, NW Hoyt Street, NW Sixth Avenue and NW Broadway, and in the legend designated as follows: "Parcel 3".


