ORDINANCE No. 149477

An Ordinance amending Ordinance No. 149134, being an ordinance assessing upon certain property the cost of abating and removing certain nuisances, including a fee for administration expenses for the one-month billing period ended October 31, 1979.

The City of Portland ordains:

Section 1. The Council finds:

- 1. Ordinance No. 149134 assessed the west 1/2 of Lots 9 and 10, Block 3, Albina Homestead, \$113.40 for the cost of abating and removing certain nuisances, including a fee for administration expenses for the one-month billing period ended October 31, 1979, and entered in the City Lien Docket Book 124, Page 142.
- 2. The charge was paid as an invoice and should not be included in the assessment.

NOW, THEREFORE, the Council directs:

a. Ordinance No. 149134, is amended by cancelling the assessment against the west 1/2 of Lots 9 and 10, Block 3, Albina Homestead, and reducing the total assessment of \$6,557.35 to \$6,443.95.

Section 2. The Council declares an emergency exists because of the necessity of keeping the City's financial records accurate; therefore, this ordinance shall be in force and effect from and after its passage by the Council.
