

## ORDINANCE No. 149477

An Ordinance amending Ordinance No. 149134, being an ordinance assessing upon certain property the cost of abating and removing certain nuisances, including a fee for administration expenses for the one-month billing period ended October 31, 1979.

The City of Portland ordains:

Section 1. The Council finds:

1. Ordinance No. 149134 assessed the west 1/2 of Lots 9 and 10, Block 3, Albina Homestead, \$113.40 for the cost of abating and removing certain nuisances, including a fee for administration expenses for the one-month billing period ended October 31, 1979, and entered in the City Lien Docket Book 124, Page 142.
2. The charge was paid as an invoice and should not be included in the assessment.


NOW, THEREFORE, the Council directs:

- a. Ordinance No. 149134, is amended by cancelling the assessment against the west 1/2 of Lots 9 and 10, Block 3, Albina Homestead, and reducing the total assessment of \$6,557.35 to \$6,443.95.


