

ORDINANCE No. 149486

An Ordinance establishing new salary rates for the position of Code Policy Officer in the Bureau of Buildings, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

1. It is recommended that new salary rates be established for the position of Code Policy Officer (2146).
2. The change described herein will create a budgetary savings of \$4,908.00/yr entry rate; \$4,076.00/yr after 1 year; and \$3,265.00/yr thereafter.
3. The change has been approved by the Bureau of Personnel.

NOW, THEREFORE, the Council directs:


- a. New salary rates be established for the position of Code Policy Officer (2146) in the Bureau of Buildings.
- b. The current compensation plan is hereby revised to reflect the following hourly rate adjustment:

SECTION 2. The Council declares that an emergency exists as described in Section 1 and should be accomplished without unnecessary delay; therefore, this Ordinance shall be in force and effect from and after its passage by the Council.
