

ORDINANCE No. 149495

An Ordinance amending Ordinance No. 138318 to provide for the addition of two (2) members to the Swan Island Task Force, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

- (1) That Ordinance No. 138318, passed by the City Council June 5, 1974, authorized a change in Agreement No. 13863 between the Oregon State Highway Division, the Port of Portland and the City of Portland, regarding the improvement of N. Going Street;
- (2) That the ordinance further created the Swan Island Task Force whose duty it was to formulate certain policies regarding the N. Going Street Project for the benefit of the City Council;
- (3) That the ordinance provided that the Task Force have eight (8) members and that presently it is desirable to expand the number of members to ten (10) to include a member who is part or sole owner of a business and a member who represents the transportation industry.

NOW, THEREFORE, the Council directs:

- (a) That Section 2 of Ordinance No. 138318, passed by the City Council June 5, 1974, is hereby amended to increase from eight (8) to ten (10) the number of members of the Swan Island Task Force by including a member who is a part or sole owner of a business and a member who is employed in the transportation industry.

Section 2. The Council declares:


That it is in the best interest of all parties concerned that the number of members of the Swan Island Task Force be increased as set forth above without unnecessary delay, therefore, an emergency exists and this ordinance shall be in force and effect from and after its passage by the Council.
