

ORDINANCE No. 149496

An Ordinance amending Ordinance No. 149431, being an ordinance assessing upon certain property the cost of abating & removing certain nuisances, including a fee for administration expenses for the two-month billing period ended December 31, 1979 by reducing the assessment against Lot 4, Block 4, Market St. Add. by \$50.40 and cancelling the assessment against W 89 ft. of Lot 1, Block 8, Piedmont, bf. \$113.40, and reducing the total assessment of \$4,265.80 to \$4,102.00, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

1. Ordinance No. 149431 assessed W 89 ft. of Lot 1, Block 8, Piedmont, \$113.40 and Lot 4, Block 4, Market Street Add., \$75.60 for the cost of abating and removing certain nuisances, including a fee for administration expenses for the two-month billing period ended December 31, 1979, and entered in the City Lien Docket Book 124, Page 178.
2. The Council recommended (Council Calendar No. 655) a reduction in the assessment against Lot 4, Block 4, Market Street Add. of \$50.40.
3. The assessment against the W 89 ft. of Lot 1, Block 8, Piedmont, was paid as an invoice and should not be included in the assessment.


NOW, THEREFORE, the Council directs:

- a. Ordinance No. 149431 is amended by reducing the assessment against Lot 4, Block 4, Market St. Add. by \$50.40 and cancelling the assessment against the W 89 ft. of Lot 1, Block 8, Piedmont in the amount of \$113.40 and reducing the total assessment of \$4,265.80 to \$4,102.00.

Section 2. The Council declares an emergency exists because of the necessity of keeping the City's financial records accurate; therefore, this ordinance shall be in force and effect from and after its passage by the Council.
