

ORDINANCE No. 149497

An Ordinance amending Ordinance No. 149383, being an ordinance assessing upon certain property the cost of repairing and constructing sidewalks, curbs and driveways in front thereof for the one-month billing period ended December 31, 1979, by reducing the assessments for Sellwood, Block 100, Lot 18, by \$220.00 and Sellwood, Block 78, E 1/2 of Lot 8 by \$55.00, and reducing the total assessment by \$275.00, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

1. Ordinance No. 149383 assessed Sellwood, Block 100, Lot 18, \$461.78 and Sellwood, Block 78, E 1/2 of Lot 8, \$617.76 for the repair and construction of sidewalks, curbs and driveways in front thereof for the one-month billing period ended December 31, 1979, and entered in City Lien Docket Book 124, Page 177.
2. These two assessments were partially paid by invoice and should be assessed a reduced amount.

NOW, THEREFORE, the Council directs:

- a. Ordinance No. 149383 is amended by reducing the assessments against Sellwood, Block 100, Lot 18, and Sellwood, Block 78, E 1/2 of Lot 8, by \$275.00 and reducing the total assessment of \$16,737.84 to \$16,462.84.


