ORDINANCE No. 149500

An Ordinance waiving Section 33.98.040 of the Code to permit late acceptance of Variance No. VZ 429-79, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

- 1. The Variance Committee, on December 11, 1979, acting on the application of Kim M. Oliver, deedholder, granted variance No. VZ 429-79 to reduce the minimum side yard (north) from the required six feet to three feet for the south parcel, in order to divide an existing ownership and construct a single family residence on the north parcel of Lots 10, 11, 12 and 13, Block 8, Portsmouth Villa Extended. (8602 N. Druid) Pursuant to Section 33.98.040 of the Code, written acceptance was required prior to January 11, 1980. Late acceptance was received April 9, 1980. Applicant states that acceptance was lost in mail. No appeal has been filed on variance.
- 2. The applicant requests and the auditor recomends waiver of the 30 day limit for filing acceptance in order to avoid unnecessary delay and additional costs.

NOW, THEREFORE, The Council directs:

- a. That Section 33.98.040 of the Code be waived in order to render late acceptance of Variance No. VZ 429-79 valid and the variance to be in full force and effect.
- Section 2. The Council declares that an emergency exists because the variance described in Section 1 above should be effective immediately in order to avoid unnecessary delay and costs; therefore, this ordinance shall be in force and effect from and after its passage by the Council.
