

ORDINANCE No. 149518

An Ordinance transferring \$25,000 within the General Fund from General Operating Contingency to the Special Appropriation for Removal of Condemned Buildings, AU 448, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

1. The Bureau of Buildings requires an additional \$25,000 within the budget for the Special Appropriation for Removal of Condemned Buildings during the remainder of fiscal year 79-80.
2. The Special Appropriation for Removal of Condemned Buildings requires additional funds because of increased demolition costs and a higher rate of use due to the Dangerous Buildings Code enforcement program.
3. The additional appropriation should be provided by transfer within the General Fund, from the General Operating Contingency.


NOW, THEREFORE, the Council directs:

- a. \$25,000 is transferred within the General Fund from General Operating Contingency to the Special Appropriation for Removal of Condemned Buildings, AU 448, BUC 44813599, Miscellaneous Services, .260.


Section 2. The Council declares that an emergency exists because the appropriation is needed immediately in the account to which it is transferred, so that there be no program interruption or administrative delay; therefore, this Ordinance shall be in force and effect from and after its passage by the Council.
