

## Introduction

The *Central City 2035 Plan* brings together more than five years of work and the voices of thousands. In addition to the outreach events and activities summarized below, hundreds of Portlanders provided formal testimony to the Planning and Sustainability Commission and City Council on the various projects that guided the development of this plan. The public will continue to play a crucial role moving forward as the Plan is refined through the CC2035 process.

This chapter summarizes highlights from the multi-year engagement process. Sections below include the public engagement summary and acknowledgements. The Outreach Activity Log and other relevant materials are attached at the end of this document.

#### **Public Engagement Summary: How We Got Here**

Public engagement for the *CC2035 Concept Plan*, each of the three quadrant plans and related work is summarized below. All of this work was integrated to develop the *CC2035 Plan*.

#### CENTRAL CITY 2035 CONCEPT PLAN (2010-2012)

An 18-member Central City Advisory Group (AG) representing stakeholders or stakeholder groups with experience in different issues and/or interests in the future of the Central City was appointed by Mayor Adams to serve for one year. All meetings of the group were open to the public and included time for public comment.

During late 2010 and 2011, City staff and the Advisory Group conducted a series of workshops and symposiums to scope the range of issues that CC2035 needed to address. At each symposium a group of expert panelists considered existing conditions, opportunities and constraints to addressing the topic discussed, and recommended strategies and objectives to better achieve the desired outcomes they identified. All events were open to the general public and included time for public comment. Approximately 435 people attended the symposiums or workshops.

- Economic Vitality: two symposiums, 21 panelists
- Housing and Community Development: two symposiums, 21 panelists
- Willamette River: two symposiums, 25 panelists
- Mobility: two symposiums, 23 panelists
- Public Safety: one symposium, 15 panelists
- Civic and Cultural Life: two symposiums, 29 panelists
- Urban Design: three workshops, 53 participants
- Historic Resources: two symposiums, 25 panelists

A 17-member Central City 2035 Steering Committee met eight times to guide staff on the development of a Concept Plan to develop policies and guidance for the quadrant plan process. All meetings were open to the public and included time for public comment.

#### THE QUADRANT PLANS (2010-2015)

Public events, meetings, project milestones and opportunities for engagement were promoted and featured on each project's respective website; the BPS website; in quadrant-specific and BPS e-newsletters and emails; on social media; and in various newspapers including the Oregonian, Daily Journal of Commerce, Willamette Week and Portland Tribune.

#### N/NE Quadrant Plan (2012)

A 30-member stakeholder advisory committee (SAC) met 19 times and held an additional 14 subcommittee meetings. All meetings were open to the public and provided opportunity for public comment. In addition:

- Staff attended 100 community meetings, reaching more than 1,100 people
- Staff hosted 10 public events, reaching nearly 600 people
- Web tools and surveys reached an additional 140 people



#### West Quadrant Plan (2015)

A 33-member stakeholder advisory committee (SAC) met 16 times. All meetings were open to the public and provided opportunity for public comment. In addition:

- Staff attended 110 community meetings, reaching approximately 1100 people
- Staff hosted 12 public events, reaching more than 400 people
- Web tools, mailers and surveys reached an additional 700 people



In the summer of 2015 after City Council adopted the West Quadrant Plan, the City Ombudsman received an anonymous complaint from a group of concerned community members. They claimed that certain members of the West Quadrant SAC had conflicts of interest that weren't disclosed in the course of the committee's work — and should have been. Attachment B provides the relevant information related to this complaint.

#### Southeast Quadrant Plan (2015)

A 30-member stakeholder advisory committee (SAC) met 14 times. In addition, open-membership working groups were formed, focusing on the 1) Central Reach; 2) transportation; and 3) policy. These groups met numerous times during the quadrant process.

- Staff attended 93 community meetings, reaching nearly 500 people
- Staff hosted 15 public events related to the quadrant and Willamette River, reaching an additional 500 people
- Web tools and mailers reached an additional 1,000 people

#### Quadrant Plan Technical Advisory Committees


Two Technical Advisory Committees (TAC) were formed during the quadrant processes: one for the N/NE Quadrant Plan and a joint committee for the West and Southeast Quadrant Plans, as these plans were done concurrently. These committees were made up of representatives from public agencies with specialized expertise. TAC members were responsible for reviewing project proposals, providing comments to project staff and reporting back to their agencies throughout the planning process.

#### **RELATED WORK**

In addition to the quadrant planning efforts, other projects were undertaken and incorporated into the *CC2035 Plan*.

#### Central City Parking Policy Update

The Central City Parking Policy Update was part of the *CC2035 Plan* and part of an effort by PBOT to develop a comprehensive Citywide Parking Strategy. This planning process was tasked with updating the parking policies guiding administration and provision of parking in the Central City as well as updating the implementing tools to achieve those policies. Existing policies in City Code Title 16 (Vehicles and Traffic) guide the administration of public parking, including on-street parking. Existing policies in City Code Title 33 (Zoning) impact the type and number of parking spaces that can be built on private sites. Public involvement for the Central City Parking Policy Update included a parking symposium with an estimated 160 attendees, a 30-member



stakeholder advisory committee, an open house, an online survey, presentation at all Mixed Use Zones events, and 35 presentations at community groups, organizations, and events throughout the Central City and beyond for an estimated total reach of 966 contacts.

#### Central City Floor Area Ratio Bonus and Transfer Study (2015)

BPS worked with the Portland Housing Bureau (PHB) and consultants Economic & Planning Systems (EPS) and Otak to complete a feasibility study for an update to the Central City's density bonus and entitlement transfer system. In conjunction with BPS and PHB, the process actively involved staff from Parks, Development Services, Commissioner Dan Saltzman's office, the Mayor's office, and others who collectively served on a monthly basis as the Executive Oversight Committee. The project also engaged external stakeholders, including affordable housing, residential and non-residential developers and brokers, builders, non-profit organizations, legal experts, and other industry professionals in one-on-one interviews and several roundtable discussions.

#### Central City Scenic Resources Protection Plan

The first step in updating the management of scenic resources in the Central City was to inventory existing resources. BPS asked the public for nominations of potential new views and viewpoints in the summer of 2014. BPS then worked with a consultant and an inter-bureau team with staff from Portland Parks and Recreation,

Bureau of Environmental Services and Bureau of Transportation to complete the inventory. A panel of experts in the fields of landscape architecture, urban design, natural resources and cultural resources was asked to score all existing and potential views based on a number of factors such as universal scenic quality and primary focal elements. The Scenic Resources Inventory was made available for public review and comment in the spring of 2015. Following the inventory, staff evaluated the scenic resources, made protection recommendations and distributed them for public review and comment with the *CC2035 Discussion Draft*. The draft recommendations were also presented at multiple external stakeholder meetings with business and neighborhood associations and at public open house events.

#### **River Planning**

Future planning for the Willamette riverfront area was an integral part the Central City plan update and engaged City bureaus, other agencies, property owners, interested individuals and groups related to the environment, recreation, tourism, transportation and commerce. A Central Reach Working Group was formed for a few key events that openly included the aforementioned constituents. A Central Reach 2-day public workshop was held on December 4 and 5, 2013, which resulted in a future draft design concept for the riverfront area in Central City. Two public riverfront walks were held as part of the Southeast Quadrant



planning process. An agency-oriented charrette was held on the Eastbank Crescent area to explore possibilities for public access and habitat improvements.

Staff presented and discussed ideas and proposals for the Central Reach riverfront area at numerous meetings including with the: Central City 2035 quadrant plans' stakeholder advisory committees, relevant city bureaus, the Portland Waterfront Alliance, Human Access Project, Portland Boathouse, Travel Portland and the Portland Business Association. Additionally, a Portland State University Masters of Planning project on activating Governor Tom McCall Waterfront Park solicited broad-based public input that informed this planning process. River-related planning news was periodically shared with an email list of over 400 people to inform and engage those interested in river planning.

#### **DEVELOPMENT OF CC2035 PLAN**

Staff integrated the *CC2035 Concept Plan*, quadrant plans and related work into the *Central City 2035 Plan*, resolving conflicts between different efforts to create a unified document. A Discussion Draft was released for public comment on February 8, 2016 and feedback was received in a variety of ways.

Following the release of the Discussion Draft in February, more than 70 people attended open houses on both sides of the river, and even more had the opportunity to learn about the plan during drop-in hours over the course of two weeks. Project staff also attended more than 40 meetings with neighborhood associations,

property owners, and others throughout the Central City. They shared information and answered questions about the *CC2035 Plan*, gathering input on the Discussion Draft. Additionally, staff received approximately 200 written comments and letters by the March 31, 2016 deadline. Two interactive Map Applications (Map Apps) were created to help interested parties understand proposed changes to Comprehensive Plan map designations, zoning, maximum FAR and building height, and the *Transportation System Plan* (street classifications and candidate transportation projects). A comment form integrated in the Map Apps allowed the public to provide comments on specific proposals or specific properties. With the release of this Proposed Draft, staff are arranging to return to many of these stakeholder groups to explain new elements and share information on how to provide testimony and stay involved in the project.

A summary list of all activities the *Central City 2035 Plan* team participated in during development of this plan is found in Attachment A.

#### PLANNING AND SUSTAINABILITY COMMISSION HEARINGS ON CC2035 PLAN

More than 750 Portlanders provided testimony on the Proposed Draft prior to and at two public hearings that were held on July 26 and August 9, 2016. The Planning and Sustainability Commission (PSC) received and considered written, oral and online Map App comments as they worked through amendments to the Proposed Draft. On May 23, 2017, the last of 9 work sessions, the PSC voted to move forward a revised CC2035 Plan to the Portland City Council. This is the PSC Recommended Draft.

# West Quadrant Stakeholder Advisory Committee (SAC) Ethics Complaint and Disclosure Summary

### Introduction

In the summer of 2015, the City Ombudsman received an anonymous complaint from a group of concerned citizens (Attachment 1). They claimed that certain members of the West Quadrant SAC had conflicts of interest that weren't disclosed in the course of the committee's work — and should have been.

The Bureau of Planning and Sustainability, like many other City bureaus, convenes stakeholder advisory committees to provide valuable "on the ground" perspectives as we develop policy and land use recommendations throughout the city. Our goal in forming these committees is to assemble a group that is balanced, with a variety of skills, knowledge, experience and perspectives. We invite property owners, business owners, neighborhood association representatives, advocacy groups and others to participate. In general, these committees, like the West Quadrant SAC, are recommending bodies and make recommendations on proposed land use plans, maps, and regulations to the Planning and Sustainability Commission.

The Ombudsman researched the issues raised in the complaint and concluded that that West Quadrant SAC members were public officials under the state ethics laws. According to those laws, a public official has a potential conflict of interest when the official takes an action that could financially benefit or harm the official, a relative, or business that the official or relative owned or worked for. A potential conflict of interest must be disclosed publicly. Once a potential conflict is disclosed, the SAC member may participate in and vote on the matter giving rise to the conflict. The Ombudsman concluded the West Quadrant SAC members may have had potential conflicts of interest that were not disclosed during the time they served on the SAC

As a remedy, the Ombudsman's letter (Attachment 2) recommended that BPS call for West Quadrant SAC members to publically disclose any potential conflicts of interest before the Planning and Sustainability Commission or the City Council hold hearings on and adopt the final plan.

### Disclosure

In response to the complaint and the Ombudsman's recommendation, BPS sent a letter (Attachment 3) and a disclosure form (Attachment 4) to the West Quadrant SAC members and asked them to complete the form and return it. BPS followed up with a FAQ (Attachment 5) that responded to questions received.

Twenty-six members completed the form, three did not complete the form but sent an email that included similar information, one email bounced, and three members did not complete the form. Table 1 summarizes the information collected to date. The full responses are available for review at the Bureau of Planning and Sustainability.

There is a growing perception that the process for creating Portland's Comprehensive Plan Update (and the West Quadrant Plan specifically) has not been consistent with the City's own standards for transparent, equitable, and ethically uncompromised stakeholder involvement.

Moreover, the process may not be consistent with Title VI of the Civil Rights Act of 1964, the City Charter's Code of Ethics 1.03.030, or the mandate of Statewide Planning Goal 1 to "involve a cross-section of affected citizens in all phases of the planning process....broadly representative of geographic areas and interests...selected by an open, well-publicized process." All land use actions in the State of Oregon are required to comply with this and other Statewide Planning Goals.

Most troubling, there is a growing perception that vested interests have been granted undue influence on the West Quadrant Plan. This perception has been expressed on the record by at least one member of the City Council. At the public hearing in which the West Quadrant Plan was considered, Commissioner Amanda Fritz was quoted in an Oregonian article stating "I'm absolutely disgusted with this entire hearing." The paper reported that "Fritz went on to say that the City Council was essentially authorizing spot zoning changes to benefit a handful of developers who are tight with members of the City Council."

This perception, which is shared by growing numbers of citizens besides Commissioner Fritz, calls into question the integrity of Portland's planning processes and reduces public trust. In order to assure that public confidence is restored in the process and that changes to the culture and to the specific practices of City Staff be made, we believe that an open review of this process is necessary, and that the increased height limits and relaxed zoning that were voted on by the ethically compromised SAC should be declared invalid.

To that end, a group of concerned and affected citizens has gathered preliminary evidence on two issues, as provided herein.

1. We provide evidence that the composition of the West Quadrant Plan Stakeholder Advisory Committee (SAC) does not meet Statewide Planning Goal 1, which mandates that land use actions must occur through a citizen involvement program that "shall involve a cross-section of affected citizens in all phases of the planning process... [which] shall include an officially recognized Committee for Citizen Involvement (CCI) broadly representative of geographic areas and interests related to land use and land-use decisions." In fact, the evidence shows that the required CCI was not at all "broadly representative" but was heavily skewed to a particular sector and economic interest, specifically that of real estate development and the professions that directly benefit financially from its activities (architecture, planning, engineering, etc). (Exhibit One, attached.)

The Planning Bureau's skewed selection of SAC members also resulted in Title VI Equity Violations. West Quadrant residents were treated as annoying NIMBYS and (except for two WQ residents) were not allowed to vote on WQ decisions. Many qualified West Quadrant residents applied to be on the SAC but were not allowed to become members. One of the only residents allowed to be on the SAC is an architect who is well-known for supporting increased height limits. The Bureau made no effort to recruit residents, and, in fact, did not even seek to establish legal residency. Several SAC members are not even Portland residents, yet were, ironically, entitled to vote on Portland's future zoning and height limits. West Quadrant residents were clearly not considered to be significant stakeholders. Thus the planning bureau violated Title VI of the Civil Rights Act of 1964 since people with higher incomes and financial stakes in the decision (developers, architects, and institutions who stand to gain financially) received privileged access while residents who are non-developers, non-architects, and non-engineers, and residents who are renters, and other residents who do not stand to gain financially, had much less privileged access (or no access at all).

2. We provide evidence of possible violations of City Charter 1.03.030. The Code of Ethics Violations Section B requires individuals with financial or personal interests that will be specifically affected by a decision to withdraw from participation in the decision. 25 of the 33 SAC members were present for the vote on the final West Quadrant endorsement.

17 out of 25 SAC members voted to approve increased height limits and relaxed zoning in the West Quadrant.

16 of those 17 are owners or developers of West Quadrant properties or represented architectural, engineering, or construction interests whose companies would gain from doing business with developers in the West Quadrant. Thus 16 of the 17 voting to approve higher WQ height limits and less restrictive zoning (which will dramatically increase property values and will create significantly more work for the related professions associated with real estate development) should have disclosed their conflicts of interest and should have recused themselves from participating in discussions or voting on height limits.

The ethics violations were so egregious that several property owners or professionals with known West Quadrant property interests advocated openly for increased height limits or more favorable zoning for their properties or developments without disclosing their conflicts or recusing themselves. To cite examples documented in Exhibit Two, SAC member Goodman advocated for and voted in favor of increased allowed height and zoning changes on his own WQ properties; co-chair Williams advocated for and voted in favor of increased height limits on a parking structure on Southwest 10th that her employer plans to redevelop; members Peterson and Petrusich advocated for and voted in favor of zoning changes and increased height limits on many WQ properties owned by them or by their employer (Melvin Mark) including their proposed Public Market at the Morrison bridgehead; member Naito-Campbell advocated for properties her company owns; and other similar conflicts were identified, as documented in Exhibit Two. The full extent of ethics violations is difficult to pin down since SAC members were never asked to disclose their conflicts of interest, and third-party identification of real estate interests is very difficult since property ownership is often obscured by various corporate entity holdings.

The available evidence of potential conflicts of interest by particular individuals on the West Quadrant Plan SAC does appear to merit recusals from decision-making and/or explicit disclosures of interest – recusals that did not occur. This appearance (if not fact) of ethical impropriety is not healthy for our citizens' perceptions of the integrity and the credibility of Portland's planning process. (Exhibit Two, appended below.)

We hope that an open and impartial examination of this evidence will 1) lead to re-examination of the zone changes and increased height limits that were implemented at the recommendation of an ethically questionable SAC and were the result of a deeply flawed process and 2) begin the much-needed restoration of transparency, accountability, and adherence to ethical norms that should characterize our public planning processes.

We make this complaint as a diverse group of individuals from the affected neighborhoods in the West Quadrant, united by our concern for the city we love. We would like very much to go on the record with these concerns, but because of the potential threat of Strategic Lawsuits Against Public Participation (SLAPP) by one or more of the economic interests mentioned, we have been advised by counsel to remain anonymous. (See e.g. <a href="http://en.wikipedia.org/wiki/Strategic lawsuit against public participation">http://en.wikipedia.org/wiki/Strategic lawsuit against public participation</a>) The fact that this approach seems necessary speaks to the atmosphere of intimidation and retribution that has been created.

### 2. Ombudsman Letter

October 21, 2015

Concerned Portland Citizens:

Thank you for contacting my office and for your patience during my review. I have completed my review of your ethics complaint and wanted to share my conclusions and recommendations.

### **Summary**

On June 12, 2015, the Office of the Ombudsman received your complaint, which raised a number of concerns about the West Quadrant Plan Stakeholder Advisory Committee (SAC). I limited the scope of my review to the alleged conflicts of interest involving SAC members. I have concluded that the Bureau of Planning and Sustainability did not properly train SAC members about their legal obligations. I have also concluded that it appears likely that individual SAC members did not comply with their obligations to disclose potential conflicts of interest. As a remedy, I have recommended that the Bureau of Planning and Sustainability call for SAC members to publicly disclose any potential conflicts before the Planning and Sustainability call opportunity for disclosure, any complaints about undisclosed potential conflicts of interest should be lodged with the Oregon Government Ethics Commission.

### **Background**

Your original complaint to my office raised a number of concerns about the West Quadrant Plan SAC, including alleged violations of the Civil Rights Act, Statewide Planning Goal 1, and the City's Code of Ethics. Your complaint suggested the appropriate remedy would be to invalidate the SAC's votes to increase height limits and relax zoning. In subsequent communications, you also raised conflict of interest concerns about Commissioner Saltzman's participation in the Council vote regarding whether to adopt the West Quadrant Plan Resolution.

After a preliminary review, I concluded that the alleged violations of the Civil Rights Act and Statewide Planning Goal 1 lacked sufficient merit to warrant being part of the scope of my inquiry. The complaint does not allege a plausible claim that there was discrimination against a class of people who are protected by the Civil Rights Act, and the Bureau of Planning and Sustainability has met the requirements of Statewide Planning Goal 1. Additionally, my office lacks jurisdiction to investigate alleged ethics violations by Commissioner Saltzman. Ethics complaints against elected officials should be directed to the Oregon Government Ethics Commission. Accordingly, the scope of my review is limited to the conflict of interest allegations involving SAC members.

### <u>Analysis</u>

The threshold question is whether SAC members are public officials under state ethics law. The Oregon Government Ethics Commission has found that the definition of "public official" encompasses volunteer committee members who serve in an advisory capacity to a City agency (see Advisory Opinion No. 07A-1001). As such, SAC members clearly fall under the definition of public official. And as public officials, SAC members were required to disclose the nature of any conflicts of interest. To date, they have not.

The cause of this omission initially lies with the Bureau of Planning and Sustainability, which did not properly apprise SAC members that they were public officials subject to state ethics law. The Bureau acknowledges that it did not screen for conflicts of interest as part of the SAC selection process. Nor did it inform or train appointed SAC members on their obligations as public officials. Bureau officials indicated that members of more formal committees, like the Planning and Sustainability Commission, are informed of their status as public officials, but that Bureau officials were previously unaware that volunteer members of bureau advisory committees met the definition of public officials. According to the Oregon Government Ethics Commission's *A Guide for Public Officials*, "[i]t is imperative for government agencies . . . to ensure their public officials receive training in Oregon Government Ethics law. Those that fail to provide this training do a disservice to the public officials who they employ or who represent them" (page 3).

Nevertheless, as the *Guide* makes clear, compliance with the Oregon Government Ethics Law is the *personal responsibility* of each SAC member. As such, the Bureau's failure to train SAC members does not excuse an SAC member's failure to comply with the law (page 3).

Public officials face two types of conflict of interest under Oregon Government Ethics Law: actual and potential (see ORS 244.020(1), (12)). The Oregon Government Ethics Commission describes the difference between the two as being determined by the words "would" and "could."

"An <u>actual</u> conflict of interest occurs when an action taken by the official <u>would</u> directly and specifically affect the financial interest of the official, the official's relative or a business with which the official or a relative of the official is associated. A <u>potential</u> conflict of interest exists when an official takes action that <u>could</u> have a financial impact on that official, a relative of that official or a business with which the official or the relative of the official is associated."

(Advisory Opinion No. 07A-1001, page 3).

SAC members do not face actual conflicts of interest. In a closely analogous scenario, the Oregon Government Ethics Commission explained that actual conflicts of interest cannot occur where an advisory committee makes non-binding recommendations (Advisory Opinion No. 07A-1001, page 3). According to the SAC's charter, the SAC develops recommendations to present to City decision-makers, but it is the City Council that has the ultimate decision-making authority regarding whether to adopt the West Quadrant Plan.

SAC members still face a potential conflict of interest if they take any action that <u>could</u> have a financial impact on them, a relative or a business with which the SAC member or a relative is associated. A potential conflict of interest does not preclude anyone from being a member of the SAC or voting on a recommendation. Rather, any SAC member faced with a potential conflict of interest must publicly disclose the nature of the potential conflict of interest prior to taking any action. Based on the information you presented in your 46-page complaint, it appears likely that multiple SAC members should have – but did not – publicly disclose potential conflicts of interest before discussing and voting on recommendations for the West Quadrant Plan.

Public disclosure of a potential conflict of interest is a critical safeguard to assure the public that the planning and development recommendations to decision-makers are based on consideration of what is in the public interest, not what will most benefit the personal financial interest of an individual advisory committee member. That did not happen before the SAC voted on recommendations for the West Quadrant Plan.

### **Recommendations and Conclusion**

Options under state law to remedy the failure to publicly disclose conflicts of interest are limited. According to the *Guide*, "any official action that is taken may not be voided by any court solely by reason of the failure of the public official to disclose an actual or potential conflict of interest" (page 24). Typical enforcement takes the form of education or monetary sanctions against the individual who violated the law.

That being said, there does remain an opportunity to serve the spirit of the law. As it currently stands, the West Quadrant Plan has only been passed as a resolution by City Council, which means that it is not yet binding law. At the March 5, 2015 Council hearing, Bureau of Planning and Sustainability leaders made clear that prior to it being merged into an ordinance with other geographic area plans, the West Quadrant Plan could be refined if needed.

I recommended that the Bureau of Planning and Sustainability contact SAC members and have them disclose any potential conflicts of interest. The Bureau should then compile a disclosure document that itemizes the responses. The document should not only include the responses by the SAC members, but it should note if any members fail to respond. That document should be entered into the public record and presented to the decision-makers when the Central City Plan – of which the West Quadrant Plan is a part – goes before the Planning and Sustainability Commission in February 2016 and to City Council after that. Such action would provide the sort of transparency that Oregon Ethics law requires and help to restore public confidence in the integrity of the process. Such action would also provide Planning and Sustainability Commissioners and City Council members with information sufficient to allow them to exercise their electoral judgment in light of any potential conflicts of interest.

If you believe this proposed remedy to be insufficient, you may still bring your complaint about individual SAC members to the Oregon Government Ethics Commission (subject to any statute of limitations). The Commission does not, however, accept anonymous complaints; under ORS 244.260(1)(a) complaints must be signed.

As for the broader institutional shortcoming that your complaint revealed, the City Attorney's Office intends to develop a standard, City-wide approach to informing and training volunteer public officials on their obligations under state ethics law (and open meetings and public records law, for that matter). This is a past due and vital step to ensure that the many advisory bodies to City agencies are complying with the sunshine laws designed to make government fully accountable for the actions it takes on the public's behalf.

Thank you again for bringing your concerns to my attention.

### 3. Letter to West Quadrant SAC

Dear West Quadrant Stakeholder Advisory Committee Member,

I want to take this opportunity to thank you once again for your service on the West Quadrant Stakeholder Advisory Committee. Your work contributed to the development of a draft CC2035 document which is now on line. (<u>https://www.portlandoregon.gov/bps/69859</u>/) Watch for an email with more information about open houses and next steps.

The other reason that I am writing is to let you know that last summer the City Ombudsman received an anonymous complaint from a group of concerned citizens. They claimed that certain members of the West Quadrant SAC had conflicts of interest that weren't disclosed in the course of the committee's work – and should have been.

The Bureau of Planning and Sustainability, like many other City bureaus, convenes stakeholder advisory committees to provide valuable "on the ground" perspectives as we develop policy and land use recommendations throughout the city. Our goal in forming these committees is to assemble a group that is balanced, with a variety of skills, knowledge and experience to achieve diverse stakeholder perspectives. We invite property owners, business owners, neighborhood association representatives, advocacy groups and others to participate. Some of these members will likely have a potential conflict of interest; however, once a conflict is disclosed, the SAC member may participate in and vote on the matter giving rise to the conflict.

The Ombudsman researched the issues raised in the complaint and concluded that that West Quadrant SAC members were public officials under the state ethics laws. According to those laws, a public official has a potential conflict of interest when the official takes an action that could financially benefit or harm the official, a relative, or business that the official or relative owned or worked for. The Ombudsman concluded the West Quadrant SAC members may have had potential conflicts of interest that were not disclosed during the time they served on the SAC.

We are currently scheduled for Planning and Sustainability Commission hearings in June 2016.

To comply with the ombudsman's recommendation, we've attached a disclosure form that asks you to provide relevant information for the period of time that you served on the SAC (March 2013 through July 2014). Please fill out the attached form and email or mail it back to us by March 31, 2016.

Moving forward, we are educating all members appointed to new and future stakeholder advisory committees about the public ethics laws. We are also requesting all committee members to complete a conflict of interest disclosure form at the outset of their committee service.

### PUBLIC RECORDS AND MEETINGS LAW SUMMARY

### OREGON'S PUBLIC RECORDS LAW

### 1) Public Records Generally

- a. The Public Records Law applies to every public body, as defined by ORS 192:410(3), and includes the City and "any agency thereof" and that includes the City's boards and commissions.
- b. Presumption for Disclosure- "Every person has a right to inspect any public record of a public body in this state, except as otherwise provided...." ORS 192.420(1).
- c. "'Public Record' includes any writing that contains information relating to the conduct of the public's business, ... used or retained by a public body regardless of physical form or characteristics." (ORS 192.410(4)(a)).
- d. "Writing' means handwriting, printing, photographing, and every means of recording, including letters, words, pictures, sounds, or symbols, or combination thereof, and all papers, maps, files, facsimiles or electronic recordings." (ORS 192.420(6)).
- e. Public records may include an email or text message if it discusses the City's business, whether the record is located on City network or equipment or on personal electronic devices. Drafts are also public records.

### 2) Retention of Records

Once a record is created, a public body is responsible for retaining that record according to the retention schedules adopted by the body. The public body's custodian of records is also responsible for making public records available upon request. Contact Tim Hunt, Auditor- Records Analyst, 503-823-4565, if you have questions on document retention specific to your office/bureau's records.

### 3) Use of Home Computers (and other electronic devices)

a. Oregon's public records laws apply to e-mail correspondence about City business even when exchanged solely on City employees' or volunteers' personal computers (or other electronic devices). As a result, employees and volunteers have a responsibility to ensure retention of such e-mails and documents.

- b. Whether an e-mail or document contains information relating to the conduct of the public's business is case specific. Generally, if an e-mail or document discusses procedural or substantive aspects of your work, it will meet this test. A purely personal e-mail does not become a public record simply because it is sent by a public official. Whether the e-mail or document is prepared, owned, used or retained by a public body is al.so fact dependent. A document not in the possession of the government still can be a public record by virtue of being used or prepared by a public body.
- c. What this means in practice is that if you choose to use private computers to create City related documents or to correspond with one another regarding City business, you may be responsible for retaining the correspondence in accordance with City document retention schedules. This includes records created on personal devices, such as personal laptop or PC, Blackberry or cell phone with texting capability, or I-Pad.
- d. Information Technologies BHR Admin Rule 4.08 and Social Media BHR Admin Rule 4.08(A), for discussion of public records and records retention of electronic records and social media content.
- e. Knowingly destroying public records can constitute a criminal offense. ORS 162.305.

### 4) Public Records Exemptions

State law provides that certain public records may be withheld from disclosure if they fall within a statutory exemption. Generally, exemptions do not prohibit disclosure; they allow the public body, through its authorized representative (generally, an elected official, bureau director or designated public body's custodian of records, with guidance from legal staff) to decide whether to rele9se a record. The presumption is in favor of disclosure and a requestor may challenge a public body's decision not to release a record.

### **OREGON'S PUBLIC MEETINGS LAW**

### 1) Meetings Subject to the Law

"All meetings of the governing body of a public body shall be open to the public and all persons shall be permitted to attend any meeting except as otherwise provided [in the Public Meetings Law]." (ORS 192.630(1)).

- a. "Governing body"- 'the members of *any* public body which consists of two or more members, with authority to make decisions for or recommendations to a public body or administration." ORS 192.610(3) (Emphasis supplied).
- b. "Public Body"- "the state, any regional council, county, city or district, or any municipal or public corporation, or any board, department, *commission,* council, bureau, *committee,* or *subcommittee,* or *advisory group or agency thereof.*" ORS 192.610(4)
- c. "Meeting"- "the convening of a governing body of a public body for which a quorum is required in order

to make a decision or deliberate toward a decision on any matter." ORS 192.610(5) (Emphasis supplied).

### 2) Gatherings Exempt from the Law

"Meeting" does not include an on-site inspection of a project or program; attendance of members of a governing body at any national, regional or state association to which the public body or the members belong; or gatherings of a quorum of a board or commission where no official business is discussed.

### 3) **Quorum Requirement**

If a quorum of a public body gets together and deliberates on official business, regardless of the setting, there is a violation of the public meetings law if the required notice was not provided. If gathering is less than a quorum of the body, there is no public meeting.

### 4) Other Situations

Purely social gatherings of a public body do not create a public meeting unless there is quorum and it decides to discuss matters relevant to its work. It is best not to discuss business at all during a social gathering. If you have a quorum present, even if the sole purpose of the meeting is to gather information to serve as the basis of future decisions or recommendations, then it is a public meeting.

In addition, electronic communication among a quorum of the public body could constitute a public meeting, especially if the communications are sent within a short time frame.

### 5) What is Required for a Public Meeting

- Notice
  - Calculated to give actual notice to interested persons
  - States time and place, lists principle subjects
  - Special and emergency meetings have different requirements

### Location

Meetings of governing bodies of public bodies shall be held within the geographic boundaries of the area over which the public body has jurisdiction, at the public body's administrative offices (if any) or "at the other nearest practical location."

Must be at a place large enough to hold the anticipated attendance and must be a place that does not discriminate on the basis of race, color, creed, sex, sexual orientation, national origin, age or disability. Site must be one that people with disabilities can access.

### • Public Attendance

As a general rule, the right to know about and attend a public meeting does not include a right to testify. The public meetings law is a public attendance law, not a public participation law

### Control

The presiding officer is authorized to keep order at a meeting and, where there will be public

participation, may determine the length of time people may speak and in what order the testimony will be taken.

### Voting

- All official action must be by public vote
- No secret ballots.
- The vote of each member must be recorded unless there are 26 or more members.
- Written ballots are allowed but each ballot must identify the member voting and the vote must be announced.
- As a general rule, no proxy voting.
- No absentee voting. That is, no voting by a member, who did not participate whether in person or electronically as by telephone.

### • Minutes

There shall be sound, video, written notes or digital recordings of all meetings. These need not be verbatim but must give a true reflection of the matters discussed at the meeting and the views of  $\cdot$  the participants." ORS 192.650(1). There are minimum requirements for the minutes and these include who was present, the substance of discussion and the results of the vote.

### 6) <u>Executive Sessions</u>

An executive session is a meeting or portion of a meeting of a governing body that is closed to the general public. An executive session is not closed to the media. However, the governing body may require that the media not disclose specified information.

There are limited purposes for an executive session which include employment, employee discipline, labor and real estate negotiations, and consultation with legal counsel regarding current or potential litigation. Agoverning body may also go into executive session to consider records exempt from public inspection. For example, a governing body may meet in executive session to discuss written legal advice from counsel because the written advice is exempt from public inspection ·as a privileged document.

A governing body may not make a final decision in executive session. To make a final decision, the chair must continue the decision to a public meeting or call the executive session into open session. Agoverning body may not remain in executive session to discuss or deliberate on matters other than the matter for which the session was convened.

### I. GIFTS

### Use of official position and gifts

*Under* state *Jaw,* you may not use your official position to obtain financial gain or avoid financial loss except:

- 1. Official compensation.
- 2. Reimbursements from employer.
- 3. Unsolicited award for professional achievement
- 4. Gifts cumulatively valued at \$50 or less from source with legislative/administrative interest per calendar year.
- 5. Gifts from source without legislative/administrative interest.
- The receipt of any item, regardless of value, that is excluded from the definition of gift in ORS 244.020.

. *Under* state *law*, regardless of whether or not you are using your official position, you may not accept within one calendar year gifts of more than \$50 from a source with a legislative or administrative interest.

# HOWEVER, the BHR administrative rules regarding gifts are more restrictive than state law in some respects.

Under the City's administrative rules, you may not use your position to receive a gift of any value offered due to your position and work for the City or that would not have been available but for your position and work for the City, regardless-of whether the source of the gift has a legislative or administrative interest, with limited exceptions described below.

### What is a gift?

Agift is something of economic value given to you or relative/household members without valuable consideration of equivalent value that is <u>not</u> extended to others who are not public officials on same terms and conditions.

#### What is a legislative/administrative interest?

Legislative/administrative interest is:

An economic interest, distinct from that of the general public, in any matter subject to the decision or vote of the public official acting in public official's capacity as a public official.

Under state law, the focus is on the scope of a public official's decision making authority.

Under City administrative rules, the focus is on whether you received the gift because of your City position.

#### What items are excluded from the definition of gift?

The following are not gifts and are exempt from the state \$50 limit and the City's gift prohibition:

- 1. Campaign contributions.
- 2. Gifts from relatives/household.
- 3. Engraved plaques, trophies, desk items unless valuable material.
- 4. Admission, food *or* beverage if representing government at a reception, meal *or* meeting. This exemption does not authorize private meals.
- 5. Expenses for food, lodging, travel paid by government, membership organization to which City pays dues for attendance or non-profit at convention, fact finding mission, trip or other meeting if you represent City. **Requires prior written authorization from supervisor.**
- 6. Expenses for food, lodging, travel paid by anyone if fact finding, trade promotion or economic development mission. **Requires prior written authorization from supervisor.**
- 7. Waiver or discount of registration materials/expenses at continuing education event to satisfy professional licensing.
- 8. Expenses provided by another public official for in-state travel (carpool). Not included in City administrative rule, but if travel is for work purposes, City would not consider it a gift to the public official.
- 9. Food or beverage at reception where no cost is placed on food.
- 10. Incidental entertainment.
- 11. Entertainment received by public official or staff where public official appears for ceremonial purposes.

City HR administrative rule 4.07 includes the following additional exceptions:

- 1. Officials may accept promotional items of little or no value that are offered to all attendees at an event.
- 2. Officials may accept raffle items or other incentives from the City at a City-sponsored event, but should not accept raffle items at other events where the official is attending due to position and work with the City or while the official is one the job during working hours.
- 3. Offices or bureaus may accept small gifts under \$25 on behalf of the office that are meant to be shared by employees, such as food or flowers. However, officials must be mindful of state law limitations.

4. Gifts of other benefits as result of volunteer service. Receipt is OK under certain conditions, including the official did not receive the volunteer position or gift because of the official's City position.

### NOTES:

- If public official is owner or manager of private business and had that position before becoming a public official, the official may accept certain gifts where there is a usual and customary business practice and the gift bears no relationship to the official's holding of office.
- Government agencies may use own resources on own public officials for food, travel etc., if allowed by City policy.

### **II. CONFLICTS OF INTEREST**

### What is a conflict of interest?

Apublic official is met with a conflict of interest when participating in official action which could (potential conflict) or would (actual conflict) result in a financial benefit or detriment to the public official, a relative of the public official or a business with which either is associated.

### What do you do when you have a conflict?

1. Elected officials or board and commission members

When an elected or appointed public official serving on a board or commission has a **potential** conflict of interest, the official must announce publicly the nature of the potential conflict prior to taking any action thereon in the capacity of a public official

When an elected or appointed public official serving on a board or commission has an **actual** conflict of interest, the official must announce publicly the nature of the actual conflict and refrain from participating as a public official in any discussion or debate on the issue out of which the actual conflict arises or from voting on the issue. Note that there are special rules for planning commission members.

### 2. City employees

City employees must notify their immediate supervisor of a conflict of interest **in writing** and request that the supervisor dispose of the matter giving rise to the conflict or give approval to the employee to take action.

### **III. SUBSEQUENT EMPLOYMENT**

- a. State law: May not use confidential information gained as public official to further personal gain after leaving public position.
- b. State law: Public officials who authorized or had significant role in a contract may not have a direct, beneficial, financial interest in the contract for two years after leaving position.
- c. City Code 2.12.080: For one year after leaving city, no lobbying of city officials on matter on which employee personally and substantially participated. With respect to contracts,

prohibition is permanent.

Significant role=approving, recommending approval, serving on selection committee

### **IV. NEPOTISM**

- d. Public official may not appoint, employ or promote a relative or member of household from position with public body that official serves unless official complies with conflict of interests regulations.
- e. May not participate in interviews, discussion or debate re: appointment, employment or promotion of relative from position with public body unless complies with conflict of interest regulations.
- f. May not directly supervise relative or member of household we already have HRAdministrative Rule 3.10 doing much the same.

### V. POLITICAL ACTIVITIES – ORS 260.432

Non-elected City employees and volunteers:

- <u>May not</u> spend time on the job promoting or opposing candidates or ballot measures.
- <u>May not</u> spend time on the job promoting or opposing political committees or the gathering of signatures for proposed ballot measures.
- <u>May not</u> use City resources to promote or oppose candidates, ballot measures or political committees or the gathering of signatures for a proposed ballot measure.
- <u>May not</u> require or attempt to require or coerce another City employee to engage in any political activity.

Non-elected City employees and volunteers:

- <u>May</u> express <u>personal</u> political views, subject to bureau rules.
- May engage in political activities outside of work, subject to bureau rules.

Elected City officials:

- <u>May not</u> require or attempt to require or coerce a City employee or volunteer to engage in political activity of <u>any</u> kind at <u>any</u> time.
- <u>May not</u> use City property, City funds, or City staff to promote or oppose ballot measures, signatures on proposed measures, political committees, or election or recall of officials or candidates.
- <u>May not</u> serve on or under any committee of a political party.

# 5. Frequently Asked Questions

# Bureau of Planning and Sustainability Central City 2035: Questions about Disclosure by Public Officials March 30, 2016

In the summer of 2015, the City Ombudsman received an anonymous complaint claiming that certain members of the West Quadrant Stakeholder Advisory Committee (SAC) had conflicts of interest that weren't disclosed in the course of the committee's work — and should have been. The West Quadrant SAC made recommendations to Bureau of Planning and Sustainability (BPS) staff about a plan that included policies, conceptual zoning code and mapping changes and actions for the west quadrant of the Central City. BPS staff prepared a proposed plan that the PSC amended. Then the City Council amended the PSC's recommended West Quadrant Plan and adopted it by resolution. The West Quadrant Plan, along with three other quadrant plans, have been incorporated into the Central City 2035 Plan that is scheduled for PSC hearings in June 2016 and Council consideration and adoption in fall 2016. The CC2035 Plan may be modified by either the PSC or Council before it is finally adopted.

The Ombudsman researched the issues raised in the complaint and concluded that the West Quadrant SAC members were "public officials" under the state ethics laws and, therefore, should have disclosed any conflicts of interest they had related to the West Quadrant planning process.

As a remedy, the Ombudsman recommended that BPS staff facilitate disclosure by SAC members of any conflicts of interest and include a disclosure document in the public record before the Planning and Sustainability Commission hearing and City Council consideration of the Central City 2035 Plan later this year.

BPS sent a disclosure form to the West Quadrant SAC members and received a number of questions. This document provides general answers to those questions by summarizing the relevant requirements of the state Government Ethics Law (ORS Chapter 244) and the City Ethics Code. As always, the precise application of these requirements to individual situations is fact-specific. The questions and answers below do not constitute legal advice. Each person should consult their own attorney for answers to any questions concerning their specific situation.

# A. Understanding Public Ethics Law

### 1. What is a public official?

A "public official" is any person who is serving the State of Oregon or any of its political subdivisions or any other public body as ... an *appointed official* ... irrespective of whether the person is compensated for the services. The Ombudsman determined that West Quadrant SAC members meet the legal definition of public officials.

2. What is the difference between a potential conflict and an actual conflict, and what should a public official do in each situation?

A public official is met with a conflict of interest when participating in an official action that *could* (potential conflict) or *would* (actual conflict) result in a financial benefit or detriment to that public official, a relative of that public official, or a business with which either is associated. [ORS 244.020(1), (13))

When an appointed public official serving on a board or commission has a <u>potential</u> conflict of interest, the official must announce publicly the potential conflict prior to taking any action thereon in the capacity of a public official.

When an appointed public official serving on a board or commission has an <u>actual</u> conflict of interest, the official must announce publicly the nature of the actual conflict and refrain from voting or otherwise participating in any discussion or debate on the issue.

For more information please see Oregon Government Ethics Law-Oregon Guide for Public Officials, page 21. (Attached)

3. How should the public announcement of the nature of a conflict of interest be recorded? The public body on which the public official serves should record the disclosure of the nature of the conflict of interest in the official records (minutes, audio/video recording).

4. If a public official failed to announce the nature of a conflict of interest and participated in an official action, is the official action voided?

No. Any official action that is taken may not be voided by any court solely because the public official failed to disclose an actual or potential conflict of interest [ORS 244.130(2)].

If someone believes a public official has violated the Government Ethics laws, that person may file a complaint with the Government Ethics Commission. The Commission will investigate the complaint and, if the Commission agrees the public official has violated these laws, it may require the public official to pay a fine of up to \$5,000 (ORS 244.350 (a)). The public official is personally liable for paying the fine, not the government body the public official served, and cannot be represented by the government body before the Commission.

# B. Understanding the Process Going Forward

1. Since this disclosure request is being made after the fact, will the disclosure form responses be confidential? If not, who will have access to them and for what purpose?

The conflict of interest disclosure forms will be a public record. As a public record, anyone, including the media, can ask to review them. BPS plans to summarize the disclosure information for the Planning and Sustainability Commission and City Council.

2. Do the complainants need to be afforded anonymity, or is that merely an accommodation? City Code requires the **Ombudsman to protect the confidentiality of the complainants' identities**.

3. What if someone does not comply with this request?

Any noncompliance with the request will be noted to the Planning and Sustainability Commission and City Council.

4. How could the retroactive remedy recommended by the Ombudsman have any impact on the project? Because neither the Planning and Sustainability Commission nor City Council has made a final decision on the CC2035 Plan, either body may take the completed forms into consideration as part of their final decision-making on the Plan. Either body could choose to amend or delete policies and items in the previously accepted West Quadrant Plan. 5. Why does this apply to the SAC when their role was not about decision-making? **The SAC's role was** to provide input to staff. State ethics law applies to volunteer members of advisory committees.

### 6. Can I appeal the Ombudsman's decision?

No. The Ombudsman provided an opinion and recommendation. BPS accepted the recommendation and chose to implement it. BPS's decision is not subject to appeal.

### C. Filling out the Disclosure Form

1. What is the scope of the disclosure? "Property owned by ... any business with which I was associated" could include anything that I worked on for any of my clients over that period, or any other property owned by any of my clients or prospects.

ORS 244.020(3)4 provides the **definition of a "business with which the person is associated," paraphrased as** follows:

In brief, a public official or the relative of the public official is associated with a business in the following circumstances:

- When, during the preceding calendar year, a public official or relative has held a position as director, officer, owner, employee or agent of a private business or a closely held corporation in which the public official or relative held or currently holds stock, stock options, equity interest or debt instrument over \$1,000.
- When, during the preceding calendar year, the public official or relative has owned or currently owns stock, equity interest, stock options or debt instruments of \$100,000 or more in a publicly held corporation.
- When the public official or relative is a director or officer of a publicly held corporation.
- When a public official is required by ORS 244.050(5) to file an Annual Verified Statement of Economic Interest form and the business is listed as a source of household income.

Also see the guidance provided in the Oregon Government Ethics Law-Oregon Guide for Public Officials.

2. My spouse works for a large corporation. I don't know how to even begin to find out if that company contracted with the City in 2012. Any advice?

Please provide your spouse's title and employer and a general description his/her work on the disclosure form so that others can understand the relationship to the Central City and the work of the SAC.

## D. Use of the information supplied on the disclosure forms

1. How will the information be used? Has there been any resolution with the complainants? Or, are they free to use whatever comes from this disclosure to try to obstruct the process at the next level or make claims against anyone?

The City Ombudsman will consider the specific complaint resolved once the disclosures are presented to the PSC and Council. However, there is nothing prohibiting the complainants from submitting subsequent complaints to the City Ombudsman or the state.

2. Will SAC members be provided a release for participating in this process?

A public official is personally liable for individual violations of Oregon ethics law. The City may neither indemnify nor represent the official before the Oregon Government Ethics Commission.

3. Will staff re-evaluate the input in light of the disclosures? How will disclosures be used in the processes going forward?

BPS has already developed a CC2035 Discussion Draft and will consider public feedback on that draft as they prepare the Proposed Draft. On May 10, BPS will release a Proposed Draft that will be the subject of a June 14 hearing before the Planning and Sustainability Commission.
