

ORDINANCE No. 190282

Authorize an Intergovernmental Agreement with Metro for a total amount of \$839,351 for the Annual Waste Reduction Plan, Business Technical Assistance & Outreach, and Business Food Waste Requirement (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

1. Metro has notified the City of Portland's Bureau of Planning and Sustainability (BPS) that Metro will award BPS \$839,351 in FY 20-21. The funding is intended to support Metro's work in the following areas: Annual Waste Reduction Services for \$348,062; Business Technical Assistance & Outreach for \$413,889; and Business Food Waste Requirement for \$77,400.
2. The funding amount of \$838,674 was included in BPS' FY20-21 Adopted Budget, and the remaining balance of \$677 will be appropriated in the Spring BMP of 2021.
3. Metro funds continue to support mutual regional and citywide goals for improved efforts in waste reduction, recycling and composting programs.
4. No City match is required.

NOW, THEREFORE, the Council directs:

- a. The Mayor is hereby authorized to accept on behalf of the City of Portland funding from Metro in the amount of \$839,351 and to execute an intergovernmental agreement with Metro, substantially similar to Exhibit A.
- b. The Office of Management & Finance's Grants Office is authorized to perform all administrative matters related to the grant application, grant agreement or amendments, requests for reimbursement from the grantor, and to submit required online grant documents on the Mayor's behalf.
- c. The BPS Director is authorized to execute any subsequent modifications to this intergovernmental agreement, provided such modifications do not increase the City of Portland's financial obligation or risk. Any modifications that increase the City's financial obligation or risk must be authorized by the City Council.
